INVITATION TO BID


1. The City Government of Malolos, through the Budget for the contract approved by the Sangguniang Panlungsod for 2022, intends to apply the sum of:
 - a. **Two Million Five Hundred Thirty Thousand Pesos** (Php 2,530,000.00) being the Approved Budget for the Contract (ABC) to payments under contract for **Concreting of Road at Sevilla St., Barangay Atlag, City of Malolos, Bulacan**. **Source: 20% Development Fund**
 - b. **One Million Eight Hundred Thousand Pesos** (Php 1,800,000.00) being the Approved Budget for the Contract (ABC) to payments under contract for **Proposed Widening and Upgrading of Road at Tabon, Barangay Atlag, City of Malolos, Bulacan**. **Source: 20% Development Fund**
 - c. **Four Million Eight Hundred Twenty-Two Thousand Four Hundred Pesos** (Php 4,822,400.00) being the Approved Budget for the Contract (ABC) to payments under contract for **Upgrading of Road at Narra, Apitong St., San Vicente, City of Malolos, Bulacan**. **Source: 20% Development Fund**

Individual bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The City Government of Malolos now invites bids for the subject bid items. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Projects. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
4. Interested bidders may obtain further information from Atty. Cyrus Paul S. Valenzuela and inspect the Bidding Documents at the address given below from 8:00 in the morning to 5:00 in the afternoon during working days.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment for the Bidding Documents for all items amounting to Five Thousand Pesos Only (Php 5,000.00).
6. The City Government of Malolos will hold a **Pre-Bid Conference** on **August 5, 2022 (Friday), 10:00 am** at **4th floor, Auditorium, New City Hall Building, McArthur Highway, Brgy. Bulihan, City of Malolos, Province of Bulacan** which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered on or before **August 16, 2022 (Wednesday), 10:00 a.m** at **4th floor, Auditorium, New City Hall Building, McArthur Highway, Brgy Bulihan, City of Malolos, Province of Bulacan**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bids will be opened in the presence of the bidders' representatives who choose to attend bid opening on **August 16, 2022 (Wednesday), 10:01 am** at **4th floor, Auditorium, New City Hall Building, McArthur Highway, Brgy Bulihan, City of Malolos, Province of Bulacan**.

LATE BIDS SHALL NOT BE ACCEPTED.

8. The City Government of Malolos reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without hereby incurring any liability to the affected bidder or bidders.
