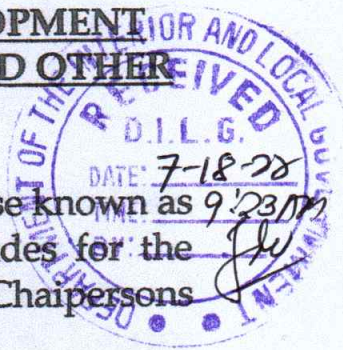

### AN ORDER APPOINTING THE LOCAL YOUTH DEVELOPMENT OFFICER, DEFINING ITS POWERS AND FUNCTIONS AND OTHER PURPOSES.

WHEREAS, Section 21 (a) of Republic Act 10742, otherwise known as the "Sangguniang Kabataan (SK) Reform Act of 2015" provides for the organization of the Pederasyon ng mga Sanggunang Kabataan Chairpersons of Barangays in the municipality, city, and provincial level;



WHEREAS, Section 26 (a), Rule IV of the Implementing Rules and Regulations of R.A. 10742, provides for the creation of a Local Youth Development Office (LYDO) in every province, city, and municipality;

WHEREAS, the law allowed that if the Local Government Unit (LGU) shall exceed the prescribed limitations on personal/personnel services, the Local Chief Executive may designate existing personnel fit to serve the purpose;

WHEREAS, to comply with the provisions mandated by law and as there is a need to enhance and augment the needed services on effective implementation of plans, programs, and activities of the youth in the city;

NOW THEREFORE, I, ATTY. CHRISTIAN D. NATIVIDAD, City Mayor of Malolos, Bulacan, by the powers vested in me, do hereby order, to wit;

**SECTION I. - LOCAL YOUTH DEVELOPMENT OFFICER.** Appointing **MR. BRYAN PAULO SIBAYAN SANTIAGO** as the concurrent Local Youth Development Officer.

**SECTION II. - DUTIES AND FUNCTIONS.** The duties and functions of the Local Youth Development Officer shall read as follows:

- a. Register and verify youth and youth-serving organizations in accordance with Youth Organizations' Registration Program (YORP) guidelines;
- b. Provide technical assistance to the Local Youth Development Council (LYDC) in the formulation of Local Youth Development Programs (LYDP);
- c. Facilitate the election of the LYDC representatives;
- d. Serve as the Secretariat to the LYDC;
- e. Conduct the mandatory and continuing training of SK Officials and LYDC members in accordance with the programs jointly designed and implemented by the National Youth Commission (NYC) and the Department of Interior and Local Government (DILG);
- f. The LYDO shall apply for accreditation from the NYC prior to the conduct of the mandatory and continuing training programs of SK Officials and the LYDC members;
- g. Provide technical, logistical, and other support in the conduct of the mandatory and continuing training programs and to such other support in the conduct of mandatory and continuing training programs and to such other programs of the NYC and the DILG;
- h. Coordinate with the NYC with regard to the youth programs within their jurisdiction; and
- i. Perform such other functions as may be prescribed by law, ordinance, or as the LCE, the DILG or the NYC may require.

**SECTION III. SEPARABILITY CLAUSE.** In the event that any section or part of this Order is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force or effect.

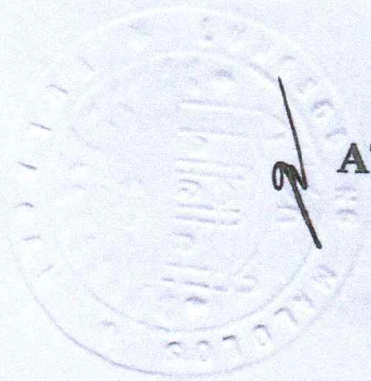
**SECTION IV. REPEALING CLAUSE.** All orders, issuances, memoranda or any part thereof inconsistent with the provisions of this Order are hereby repealed, amended or modified accordingly.

**SECTION V. DISSEMINATION.** Let a copy of this Order be sent to the Office of the Provincial Governor pursuant to Sec. 455 (b)(1)(xii) of Chapter III Art. I of R.A. 7160 known as the "Local Government Code of 1991", the City Mayor shall furnish copies of executive orders issued by him, to the provincial governor within seventy-two (72) hours after their issuances.

**SECTION VI. EFFECTIVITY.** This Order shall take effect immediately upon signing.
