AN ORDER ORGANIZING THE CREATION OF THE CITY TRICYCLE-PEDICAB REGULATORY BOARD (CMTPRB)

WHEREAS, the City Government of Malolos recognizes the rights of all the inhabitants of the City of Malolos, as to further ensure their contribution to the goals, and aspirations of the city government as well as making them participate actively in the city's progress and nation-building;

WHEREAS, the City Government deems it necessary to create a board and transport advisory body that shall formulate plans, programs, and policies to promote the welfare and interest of tricycle and pedicab organizations in the City of Malolos;

WHEREAS, under Chapter 4 of the Municipal Ordinance No. 15-2001, Municipal Tricycle-Pedicab Franchising and Regulatory Board (MTPFRB) was duly created and approved by the Sangguniang Pambayan on 19 December 2001;

WHEREAS, Executive Order No. 05 Series of 2016, also known as the Re-Organization of the Municipal Tricycle-Pedicab Franchising and Regulatory Board (MTPFRB) has been duly signed and approved on 22 July 2016 by City Mayor Atty. Christian D. Natividad;

WHEREAS, pursuant to City Ordinance No. 14-2019, the Composition, Name, Powers, and Duties of MTFRB, Sections 10 and 11 of Municipal Ordinance No. 15-2001 has been amended.

WHEREAS, Executive Order No. 20 Series of 2021, also known as the Re-Organization of the Municipal Tricycle-Pedicab Franchising and Regulatory Board (MTPFRB) has been duly signed and approved on 7 June 2021 by former City Mayor Engr. Gilbert T. Gatchalian;

NOW, THEREFORE, I, ATTY. CHRISTIAN D. NATIVIDAD, City Mayor of Malolos, Bulacan, by virtue of the power vested in me, do hereby order, to wit:

SECTION I. MEMBERS. The re-organization of the creation of the City Tricycle-Pedicab Regulatory Board (CMTPRB), as follows:

SECTION II. FUNCTIONS.

1. Study and approve proposed fare hike of tricycles and pedicabs in a particular route;
2. Through the petition of legitimate tricycle and pedicab association, this Board shall study and approve the proposed increase or decrease in fare, if it is justifiable after consultations and hearings;
3. Conduct regular meetings to evaluate properly and to give appropriate solutions with regard to the issues and concerns of the tricycle and pedicab organizations;
4. Approval of applications for transfer of ownership or transfer of right of Motorized Tricycle Operators Permit (MTO) from its original owner to another person;
5. Assurance of compliance of all tricycle and pedicab owners, operators, and drivers with all the rules and policies with regard to the Traffic Rules and Regulations of Municipal Ordinance No. 15-2001; and
6. Assignment of route, zone, or terminal of the tricycle and pedicab organizations and color coding of tricycle sidecars.

SECTION III. SEPARABILITY CLAUSE. In the event that any section or part of this Order is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force or effect.

SECTION IV. REPEALING CLAUSE. All orders, issuances, memoranda, or any part thereof inconsistent with the provisions of this Order are hereby repealed, amended or modified accordingly.

SECTION V. DISSEMINATION. Let a copy of this Order be sent to the Office of the Provincial Governor pursuant to Sec. 455 (b)(1)(xii) of Chapter III Art. I of R.A. 7160 known as the "Local Government Code of 1991", the City Mayor shall furnish copies of executive orders issued by him, to the provincial governor within seventy-two (72) hours after their issuances.


