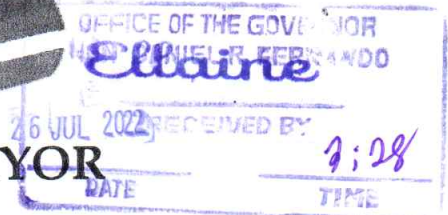

MOBILIZING AN EXECUTIVE-LEGISLATIVE AGENDA (ELA) TEAM AND DESIGNATING THE COMPOSITION OF THE ELA TEAM

WHEREAS, the Local Government Code mandates local government units to prepare a Comprehensive Development Plan (CDP) that outlines the key aspirations, challenges and concerns facing LGUs and a set of programs, projects and policies towards the sustained socio-economic development.

WHEREAS, the Executive-Legislative Agenda (ELA) serves as an implementing mechanism for the CDP, and its process ensures that the plan is reflective and supportive of the sentiments of and has generated popular support from the various stakeholders in the local government unit (LGU);

WHEREAS, the ELA process requires a team that will back up the local chief executive (LCE) in the various preparatory, consultative, and technical activities in order to come up with good quality and acceptable outputs;

NOW THEREFORE, I, CHRISTIAN D. NATIVIDAD, Mayor of the City of Malolos, Province of Bulacan, by virtue of the power vested in me by law, do hereby create and mobilize the ELA Team, to wit:

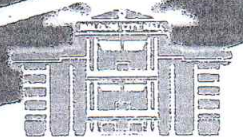
SECTION II. FUNCTIONS AND DUTIES.

- a. Review available plans and documents, and gather data required in the development of the ELA;
- b. Assist the LCE in public hearings and other consultation sessions with the various LGU stakeholders and affected sectors like the local government unit (LGU) offices, City of Malolos Development Council, Sangguniang Panlungsod and other sectoral organizations;
- c. Assist the LCE and the City of Malolos Development Council in drafting and finalizing the ELA to include the 3-Year Local Development Investment Program (LDIP), current year Executive Budget and Annual Investment Program (AIP);
- d. Assist the LCE in his presentation of the ELA to various stakeholders; and
- e. Do other tasks required by the LCE in order to produce the desired outputs.

SECTION III. RELATIONSHIP WITH THE CITY OF MALOLOS DEVELOPMENT COUNCIL (CMDC) AND OTHER UNITS. The ELA Team shall work closely with the CMDC as soon as it is reconstituted. The CMDC shall act as the reference group for the ELA team and shall participate actively, through its representative, in all stages of the ELA process.

SECTION IV. SUPPORT REQUIREMENTS. The team may call upon the assistance of relevant units and/or LGU personnel, through the respective department/unit heads, in the implementation of various activities. Everyone is enjoined to participate in the various activities of the ELA.

SECTION V. SEPARABILITY CLAUSE. If any provision of this Act is declared unconstitutional or invalid, such parts or portions not affected thereby shall remain in full force and effect.


SECTION VI. REPEALING CLAUSE. All orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION VII. DISSEMINATION. A copy of this Executive Order shall be furnished to the Office of the Provincial Governor, for its information and guidance pursuant to Section 455 (1) (xii) or R.A. 7160, as amended, and shall be posted in the City Government of Malolos' official website.

SECTION VIII. EFFECTIVITY. The Executive Order shall take effect immediately and until the project closes.
