**AN EXECUTIVE ORDER REORGANIZING THE LOCAL SCHOOL BOARD OF THE CITY OF MALOLOS IDENTIFYING ITS MEMBERS THEIR DUTIES AND FUNCTIONS AND OTHER PURPOSES**

WHEREAS, Article XIV Section 1 of 1987 Philippine Constitution prescribed that the State shall protect and promote the rights of all citizens to quality education at all levels, and shall take appropriate steps to make such education accessible to all;

WHEREAS, Section 28 of the Local Government Code of 1991 mandated the creation of school boards, its functions and budget allocation;

WHEREAS, Section 309 item (a) of the Local Government Code of 1991 states that the share in the proceeds of the additional tax on real property be appropriated for Special Education Fund;

**NOW, THEREFORE, I, Atty. Christian D. Natividad, City Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by existing and applicable law, do hereby order the re-organization of the City of Malolos School Board.**

**SECTION I: LOCAL SCHOOL BOARD COMPOSITION**

## **SECTION II: FUNCTIONS OF THE LOCAL SCHOOL BOARD**

- a. Determine the annual supplementary budgetary needs for the operation and maintenance of public schools within the city.
- b. Authorize the city treasurer to disburse funds from the Special Education Fund pursuant to the budget prepared and in accordance with existing rules and regulations.
- c. Serve as an advisory committee to the Sangguniang Panlungsod on educational matters and related issues.
- d. Recommend changes in the names of public schools within the territorial jurisdiction of the Local Government Unit for enactment by the Sangguniang Panlungsod.

**SECTION III. BUDGET.** The annual school board budget shall give priority to the following:

- a. Construction, repair, and maintenance of school buildings and other facilities of public elementary and secondary schools.

- b. Establishment and maintenance of extension classes where necessary.
- c. Sports activities at the city and barangay levels.

#### **SECTION IV. ALLOCATION OF SPECIAL FUND**

- a. Operation and maintenance of public schools
- b. Construction and repair of school buildings
- c. Educational research
- d. Purchase of books and periodicals
- e. Sports development

**SECTION V. ALLOCATION OF SPECIAL EDUCATION FUND FOR EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD).** The Local School Board shall allocate funds for:

- a. Support the implantation of their ECCD program;
- b. Organize and support parent cooperatives to establish community-based ECCD programs;
- c. Provide counterpart funds for the continuing professional development of their ECCD public service providers;
- d. Provide the facilities for the conduct of their ECCD Program.

**SECTION VI. SECRETARIAT.** The board shall designate the secretariat to support the implementation of this order.

**SECTION VII. MEETINGS.** The Local School Board shall meet once a month or as often as may be necessary.

**SECTION VIII. SEPARABILITY CLAUSE.** If any provision of this Act is declared unconstitutional or invalid, such parts or portions not affected thereby shall remain in full force and effect.

**SECTION IX. REPEALING CLAUSE.** All orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

**SECTION X. DISSEMINATION.** A copy of this Executive Order shall be furnished to the Office of the Provincial Governor, for its information and guidance pursuant to Section 455 (1) (xii) or R.A. 7160, as amended, and shall be posted in the City Government of Malolos' official website.

**SECTION XI. EFFECTIVITY**

The Executive Order shall take effect immediately upon signing.
