AN ORDER REORGANIZING THE PEOPLES LAW ENFORCEMENT BOARD (PLEB) IN THE CITY OF MALOLOS

WHEREAS, Republic Act No. 6795, otherwise known as, "The DILG Act of 1990" as amended, Republic Act 8551, or the PNP Reform Act of 1998, Republic Act 10924, or the General Appropriations Act of FY 2017, provided for the creation of Peoples Law Enforcement Boards (PLEBs) in every city or municipality

WHEREAS, the Peoples Law Enforcement Board empowers the people against abusive and erring policemen with a power to hear and adjudicate all citizens complaints formally filed with or referred to them against uniformed members of the Philippine National Police (PNP) for offenses committed in their area of jurisdiction, and impose the corresponding if warranted;

WHEREAS, Art 186 of the Implementing Rules and Regulations of Local Government Code of 1991 provides that "there shall be established in the LGU concerned a Peoples Law Enforcement Board (PLEB) pursuant to the pertinent provision of R.A 6975 (Annex D)";

WHEREAS, Article 152, Chapter IV, Title III, Book II of the Revised Penal Code, the members of the Peoples Law Enforcement Board are considered persons in authority;

WHEREAS, Section 3, Rule 11 of NAPOLCOM MC No. 2016-002, titled Revised Rules of Procedures before the Administrative Disciplinary Authorities and the Internal Affairs Service of the Philippines National Police established the composition of the Peoples Law Enforcement Board;

WHEREAS, Local Government Unit shall hold responsibility on the reorganization of the Peoples Law Enforcement Board as per Local Government Code of 1991;

NOW THEREFORE, I ATTY. CHRISTIAN D. NATIVIDAD, Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by law, in the interest of public service and in pursuant to existing laws and regulations governing the creation of the Peoples Law Enforcement Board, the City of Malolos PLEB is hereby reorganized as follows:

SECTION I. FUNCTIONS, POWERS AND DUTIES. The PLEB through its respective members are primarily tasked to conduct hearing and adjudication of citizen complaints against uniformed members of the Philippine National Police for offenses committed in their area of jurisdiction. As such, the duties, functions and responsibilities of the members of the PLEB shall be pursuant to the provisions of the Republic Acts 6975 and 8551 supplemented by the NAPOLCOM Memorandum Circular No. 2017-157.

SECTION II. HONORARIA. Pursuant to members of PLEB shall be compensated in the form of per diem and shall be taken from the available funds of the City of Malolos subject to the Local Budget Circular No. 73 s. 2001 and usual accounting and auditing rules and regulations.

SECTION III. SEPARABILITY CLAUSE. If any provision of this Act is declared unconstitutional or invalid, such parts or portions not affected thereby shall remain in full force and effect.


SECTION IV. REPEALING CLAUSE. all orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION V. DISSEMINATION. A copy of this Executive Order shall be furnished to the Office of the Provincial Governor, for its information and guidance pursuant to Section 455 (1) (xii) or R.A. 7160, as amended, and shall be posted in the City Government of Malolos' official website.

SECTION VI. EFFECTIVITY: This Order shall take effect immediately.
