

EXECUTIVE ORDER NO. 0 2 2 SERIES 2022

KON. EMMAN FORCE FOR ILLEGAL STRUCTURES IN THE CITY OF MALOLOS

whereas, Section 16 of the Local Government Code of 1991 provides that the Local Government Units shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers expressly granted, peace and order, and preserve the comfort and convenience of their inhabitants;

whereas, Sec. 455 par. (b), (3,), (vi) of the Local Government Code of 1991, provides that the City Mayor shall have the power to, "Require owners of illegally constructed houses, buildings or other structures to obtain the necessary permit, subject to such fines and penalties as may be imposed by law or ordinance, or to make necessary changes in the construction of the same when said construction violates any law or ordinance, or to order the demolition of the same when said said house, building or structure within the period prescribed by law of ordinance, 7022

WHEREAS, the construction of illegal structures in both public and private lands may prejudice the public and legitimate landowners of their right to peacefully utilize, possess, and enjoy the same;

WHEREAS, the City aims to clear both public and private lands, streets and sidewalks of all obstructions and illegal structures, so as to ensure

SECTION II. DUTIES AND FUNCTIONS OF THE TASK FORCE.

The Task Force shall investigate and recommend to the City Mayor appropriate actions on complaints for illegally constructed houses, buildings or other structures and improvements built within the City of Malolos, Bulacan;

The Task Force shall enact the necessary Implementing Rules and Regulation within twenty (20) days from the signing of this Executive Order;

SECTION III. FUNDING. The budget for the Demolition Task Force will sourced from the available funds of the City of Malolos, subject to the pertinent provisions of Local Budget Circular No. 73 s. 2001 and usual accounting and auditing rules and regulations.

SECTION III. SEPARABILITY CLAUSE. In the event that any section or part of this Order is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force or effect.

SECTION IV. REPEALING CLAUSE. All orders, issuances, memoranda or any part thereof inconsistent with the provisions of this Order are hereby repealed, amended or modified accordingly.

SECTION V. DISSEMINATION. Let a copy of this Order be sent to the Office of the Provincial Governor pursuant to Sec. 455 (b)(1)(xii) of Chapter III Art. I of R.A. 7160 known as the "Local Government Code of 1991", the City Mayor shall furnish copies of executive orders issued by him, to the provincial governor within seventy-two (72) hours after their issuances.

SECTION VI. EFFECTIVITY. This Order shall take effect immediately upon signing.
