AN ORDER RECONSTITUTING THE COMPOSITION OF THE BIDS AND AWARDS COMMITTEE (BAC) SECRETARIAT

WHEREAS, the Government Procurement Reform Act R.A. 9184, provides for the Revised Rules and other pertinent provisions of the Government Procurement System;

WHEREAS, in accordance with Section 11.2.6 of the Revised Implementing Rules and Regulations of R.A. 9184, the members of the BAC Secretariat shall have a fixed term of one (1) year reckoned from the date of appointment. Thus, the renewal of the organization of the BAC;

WHEREAS, there is a need to reconstitute the composition of the BAC Secretariat in connection with the sudden resignation of the appointed BAC-Secretariat Chairman, Mr. Marvin Gutierrez, and its member, Mr. Ariel De Borja due to personal reasons;

NOW THEREFORE, I, ATTY. CHRISTIAN D. NATIVIDAD, City Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by existing and applicable law, do hereby reconstitute the City Bids and Awards Committee (BAC).

SECTION I: RECONSTITUTION OF THE BAC SECRETARIAT

The following shall constitute the BAC-SEC.

Head of Secretariat : **ATTY. DARWIN DIONISIO CLEMENTE**

Members : **MS. DANICA ABSALON
MS. MARIA CECILA R. REYES
MS. FLORINDA S.D. TISMO
MS. RHEA MARI D.R. VALERIO**

SECTION II: TERM OF OFFICE. The term of the composition of BAC Secretariat shall be until June 30, 2030, from the date of appointment, provided that the City Mayor may attend the membership of such committee at any time.

SECTION III: DUTIES AND FUNCTIONS. The City Government of Malolos BAC-SEC shall assist in the administration and clerical matters with respect to BAC proceedings.

SECTION IV: HONORARIA. Members of the BAC-SEC shall be entitled to claim lawful honoraria, subject to the provisions of DBM Budget Circular No. 2004-5A dated 07 October 2005, in an amount not exceeding to twenty five percent (25%) of their respective monthly salary, only for successful completed procurement projects and subject to the availability of funds. The foregoing shall be subject to any prevailing DBM circulars, rules, or regulations that may be issued from time to time.

SECTION V. REPEALING CLAUSE. All orders, issuances, memoranda or any part thereof inconsistent with the provisions of this Order are hereby repealed, amended or modified accordingly.

SECTION VI. DISSEMINATION. A copy of this Executive Order shall be furnished to the Office of the Provincial Governor for its information and guidance pursuant to Sec. 455 (b)(1)(xii) of Chapter III Art. I of R.A. 7160 known as the "Local Government Code of 1991", and shall be posted in the City Government of Malolos official website.

SECTION VII. EFFECTIVITY. This Order shall take effect immediately upon signing.
