**AN ORDER REORGANIZING THE CREATION OF THE LOCAL HEALTH BOARD IN THE CITY OF MALOLOS, IDENTIFYING ITS MEMBERS, THEIR DUTIES AND FUNCTIONS AND OTHER PURPOSES**

**WHEREAS**, Article 185 of the Implementing Rules and Regulations of the Local Government Code of 1991 (Republic Act 7160) mandates the creation of the Local Health Board (LHB);

**WHEREAS**, Section 11, Article XIII of the 1987 Philippine Constitution states that the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost and there shall be priority for the needs of the underprivileged, sick, elderly, disabled, women, and children;

**WHEREAS**, the recent local elections require reconstitution of the LHB due to the end of term of office of former Local Health Board members; and;

**WHEREAS**, based on the above premises, the City Government would like to ensure the seamless transition to the new administration including the continuity of the functions and programs of the Local Health Board;

**NOW THEREFORE, I, ATTY. CHRISTIAN D. NATIVIDAD**, Mayor of the City of Malolos, Province of Bulacan, by virtue of the power vested in me by law, do hereby the creation of the Local Health Board, to wit:

**SECTION I. COMPOSITION.** The Local Health Board in the City of Malolos shall be composed of the following:

**SECTION II. DUTIES AND FUNCTIONS OF THE CITY/MUNICIPAL PEACE AND ORDER COUNCIL.** The LHB shall perform the following functions:

- a) Propose to the sanggunian concerned, in accordance with the standards and criteria set by DOH, annual budgetary allocations for the operation and maintenance of health facilities and services within the province, city, or municipality, as the case may be;
- b) Serve as an advisory committee to the sanggunian concerned on health matters such as, but not limited to, the necessity for, and application of local appropriations for public health purposes; and
- c) Create committees which shall advise, local health agencies on matters such as, but not limited to, technical and administrative standards of DOH, personnel selection and promotion, bids and awards, grievances and complaints, personnel discipline, budget review, operations review and similar functions.

### **SECTION III. MEETINGS AND QUORUM.**

- a) The LHB shall meet at least once a month or as often as may be necessary.
- b) A majority of the members of the board shall constitute a quorum, but the chairperson or the vice chairperson must be present during meetings where budgetary proposals are being prepared or considered. The affirmative vote of a majority of the members shall be necessary to approve such proposals.

**SECTION IV. FUNDING.** The City Health Board will be budgeted according to the available funds of the City of Malolos subject to the Local Budget Circular No. 73 s. 2001 and usual accounting and auditing rules and regulations.

**SECTION V. COMPENSATION AND REMUNERATION.** The co-chairpersons and members of the City health board shall perform their duties as such without compensation or remuneration. Members thereof who are not government officials or employees shall be entitled to necessary traveling expenses and allowances chargeable against the funds of the LHB, subject to existing accounting and auditing rules and regulations.

**SECTION V. SEPARABILITY CLAUSE.** If any provision of this Act is declared unconstitutional or invalid, such parts or portions not affected thereby shall remain in full force and effect.

**SECTION VI. REPEALING CLAUSE.** All orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

**SECTION VII. DISSEMINATION.** A copy of this Executive Order shall be furnished to the Office of the Provincial Governor, for its information and guidance pursuant to Section 455 (1) (xii) or R.A. 7160, as

amended, and shall be posted in the City Government of Malolos' official website.

**SECTION VIII. EFFECTIVITY.** The Executive Order shall take effect immediately and until the project closes.
