WHEREAS, Prima Lumina Gold Mining Corporation published its Notice of Application for Exploration Permit of Prima Lumina Gold Mining Corporation Designated as EXPA000197 III in Metro News Bulacan, Vol. LIII, No.2 dated June 18 - 24, 2022;

WHEREAS, the said application provides that the extent of operation to be undertaken by Prima Lumina Gold Mining Corporation involves exploration of marine sand, aggregates and other minerals affecting the area of Malolos City, Bulacan;

WHEREAS, there is an imperative need to critically study, review and evaluate the said application for exploration permit.

SECTION III. FUNCTIONS. The Committee shall investigate and recommend to the City Mayor any appropriate actions on the operation to be undertaken by Prima Lumina Gold Mining Corporation involving the exploration of marine sand, aggregates and other minerals affecting the area of Malolos City, Bulacan.

SECTION IV. SEPARABILITY CLAUSE. If any provision of this Act is declared unconstitutional or invalid, such parts or portions not affected thereby shall remain in full force and effect.

SECTION V. REPEALING CLAUSE. All orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION VI. DISSEMINATION. A copy of this Executive Order shall be furnished to the Office of the Provincial Governor, for its information and guidance pursuant to Section 455 (1) (xii) or R.A. 7160, as


SECTION VII. EFFECTIVITY
