AN ORDER PROVIDING FOR THE COMPOSITION OF THE CITY FISHERIES AND AQUATIC RESOURCES AND MANAGEMENT COUNCIL OF THE CITY OF MALOLOS

WHEREAS, it is the policy of the State to protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature.;

WHEREAS, the Philippine Fisheries Code of 1998 mandates the creation of the City Fisheries and Aquatic Resources Management Council;

NOW THEREFORE, I, ATTY. CHRISTIAN D. NATIVIDAD, City Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by existing and applicable law, do hereby the creation of City Fisheries and Aquatic Resources and Management Council of the City of Malolos.

SECTION I: COMPOSITION OF THE CITY FISHERIES AND AQUATIC RESOURCES MANAGEMENT COUNCIL. There shall be created the City Fisheries and Aquatic Resources and Management Council with the following composition:

SECTION II: FUNCTIONS OF THE CFARMC. The City Fisheries and Aquatic Resources and Management Council shall have the following functions:

1. Assist in the preparation of the City Fishery Development Plan and submit such plan to the City Development Council;
2. Recommend the enactment of city fishery ordinances to the Sangguniang Panlungsod through its Committee on Fisheries / Agriculture;
3. Assist in the enforcement of fishery laws, rules and regulations in the local water;
4. Advise the Sangguniang Panlungsod on fishery matters through its Committee on Fisheries, if such has been organized; and
5. Perform such other functions which may be assigned by the Sangguniang Panlungsod.

SECTION III: SECRETARIAT. The **CITY AGRICULTURE OFFICE** shall act as the Secretariat of City Farm and Aquatic Resources Management Council.

SECTION IV. REPEALING CLAUSE. All orders, issuances, memoranda or any part thereof inconsistent with the provisions of this Order are hereby repealed, amended or modified accordingly.

SECTION V. DISSEMINATION. A copy of this Executive Order shall be furnished to the Office of the Provincial Governor for its information and guidance pursuant to Sec. 455 (b)(1)(xii) of Chapter III Art. I of R.A. 7160 known as the "Local Government Code of 1991", and shall be posted in the City Government of Malolos official website.

SECTION VI. EFFECTIVITY. This Order shall take effect immediately upon signing.
