SECTION II. FUNCTIONS AND DUTIES. The City Retooled Community Support Program (RCSP) Team shall perform the following

a. Local Chief Executive as Head of the RCSP Team

- a.1. To champion the cause to be at the forefront of the stride of bringing the needed government interventions to the people through RSCP;
- a.2. To be in charge with the deployment of the RCSP Team to the target barangay for immersion and ensure that development initiatives are properly delivered, immediate needs are properly addressed, and long-term needs are properly programmed for funding and implementation;
- a.3. Issue a Memorandum to Punong Barangays to create the RCSP Team in the Barangay consistent with the issuance issued by the DILG for its creation and function pursuant to Memorandum Circular No. 2019-125, as amended and other issuances from the NTFELCAC;
- a.4. Issue directive to all its Department Heads for the collection and utilization of the pertinent data, information and relevant barangay profiles and assist the RCSP Team in the performance of its function;
- a.5. Issue directive to all its Department Heads to assist and work hand-in-hand with the Municipal RCSP Task Team for the validation of data and inputs from the dialogue sessions and solution-seeking tables;
- a.6. Prepare a send-off ceremony for the RCSP Team to be deployed for immersion in the targeted barangay;
- a.7. Oversee the operations of the RCSP Task Team during the entire period of immersion and perform related functions towards the successful conduct of the RCSP.

b. RCSP Core Team

- b.1. To serve as the unit that directly provides all necessary tactical, technical, logistical, and administrative assistance to the LCE in the performance of its function as the RCSP Head.

c. Basic Service Delivery Team (BSDT)

- c.1. To serve as the primary bridge of the RCSP to the national government.

d. Citizenship and Community Participation Team (CCPT)

- c.1. To organize the Citizenship Movement by mobilizing into sectoral groups and usher them to participate in all sectoral dialogues/solution-seeking tables aimed to validate the governance and development gaps of the communities;
- c.2. Identify the needed government interventions to address gaps.

d. Peace, Law Enforcement and Development Support (PLEDS) Team

- d.1. To conduct clearing operations one week prior to the actual send-off of the RCSP Team, ensure perimeter security of the target-barangay during the entire duration of the immersion and continuous sanitation of the community from terrorist threats during the implementation and provision of needed government interventions.

e. Local Development Council and Local Peace and Order Council

- e.1. To maintain a vital linkage to the RCSP Task Team for the purpose of programs and projects coordination;
- e.2. To focus on screening and prioritizing needed government interventions that must be included as a priority in the Local Development Investment Program (LDIP).

SECTION V. SEPARABILITY CLAUSE. If any provision of this Act is declared unconstitutional or invalid, such parts or portions not affected thereby shall remain in full force and effect.

SECTION VI. REPEALING CLAUSE. All orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION VII. DISSEMINATION. A copy of this Executive Order shall be furnished to the Office of the Provincial Governor, for its information and guidance pursuant to Section 455 (1) (xii) or R.A. 7160, as amended, and shall be posted in the City Government of Malolos' official website.

SECTION VIII. EFFECTIVITY. This Order shall take effect immediately.
