NOTICE

Sirs/Mesdames:

*Please take notice that the Court en banc issued a Resolution dated **AUGUST 9, 2022**, which reads as follows:*

“A.M. No. 16-05-104-RTC (Re: Creation of an Additional Branch of the Regional Trial Court in the City of San Jose del Monte, Bulacan).- The Court Resolved, upon the recommendation of the Office of the Court Administrator (OCA), to

(a) **REMOVE** (i) the Municipalities of San Ildefonso, San Miguel and San Rafael, all in Bulacan, from the territorial jurisdiction of Branch 120, Regional Trial Court (RTC), City of San Jose del Monte, Bulacan, and (ii) the Municipalities of Baliuag and Bustos, both in Bulacan, from the territorial jurisdiction of Branch 121, RTC, Meycauayan City, Bulacan;

(b) **TRANSFER** the aforesaid Municipalities to the territorial jurisdiction of the RTC, Malolos City, Bulacan;

(c) **SPELL IN FULL** the ‘R’ in the ‘Municipality of Doña R. Trinidad’ as stated in the resolution dated June 28, 2016;

(d) **AMEND** accordingly the resolution dated June 28, 2016, particularly paragraph (b) thereof, to read as follows:

(b) **FURTHER AMEND** Administrative Order No. 7 dated February 11, 1983, as amended, to read as follows:

BULACAN

1. Branches 6 to 22, Branches 76 to 85, and Branches 102 to 104, inclusive, with seats at MALOLOS CITY - over **Malolos City** and the Municipalities of Balagtas, **Baliuag**, Bulacan, **Bustos**, Calumpit, Guiguinto, Hagonoy,

Paombong, Plaridel, Pulilan, **San Rafael**,
San Ildefonso and **San Miguel**.


Branch 120 with seat at SAN JOSE
DEL MONTE CITY – over **San Jose del
Monte City** and the Municipalities of
Angat, Doña **Remedios** Trinidad,
Norzagaray, and Sta. Maria.

Branch 121 with seat at
MEYCAUAYAN CITY – over **Meycauayan
City** and the Municipalities of Bocaue,
Marilao, Obando and Pandi. [Amendments
in bold]

(e) **ORDER** the amendment of all court records to conform with this development; and

(f) **DIRECT** the Docket Division, Legal Office, OCA, to attach copies of this resolution to the records of (i) A.M. No. 14-4-97-RTC (Re: Creation of Three [3] Additional Branches of the Regional Trial Court in the City of Malolos, Bulacan) and (ii) A.M. No. 16-05-105-RTC (Re: Creation of an Additional Branch of the Regional Trial Court [RTC] in Meycauayan City, Bulacan).” Lopez, M., J., on official leave. (adv13)
