### RESOLUTION NO. 2022-10-004-AGENDA

#### COMPLIANCE WITH THE PUBLICATION REQUIREMENT FOR "SHOPPING" AS AN ALTERNATIVE MODE OF PROCUREMENT

WHEREAS, on 12 October 2022, the Bids and Awards Committee held a meeting to discuss the concerns with regard procurements through Shopping as provided under Sec. 52 of the Implementing Rules and Regulations (IRR) of R.A. 9184 or the Government Procurement Reform Act;

WHEREAS, Sec. 52.1 of the said IRR provides that:

*"Shopping is a method of procurement of Goods whereby the Procuring Entity simply requests for the submission of price quotations for readily available off-the-shelf goods or ordinary/regular equipment to be procured directly from suppliers of known qualifications.";*

WHEREAS, Sec. 54.2.4 of the same IRR provides that:

*"the BAC, through its Secretariat, shall post the invitation or request for submission of price quotations/proposals in the PhilGEPS website, the website of the Procuring Entity concerned, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity for a period of at least three (3) calendar days...(for) Small Value Procurement (For ABC above Fifty Thousand Pesos (P50,000.00));*

NOW, THEREFORE, WE, the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED, THAT ALL PURCHASES USING "SHOPPING" AS AN ALTERNATIVE MODE OF PROCUREMENT UNDER R.A. 9184 AND ITS IRR SHALL COMPLY WITH THE POSTING REQUIREMENT FOR PURCHASES WITH AN APPROVED BUDGET CONTRACT IN EXCESS OF THE THRESHOLD AMOUNT OF PHP 50,000.00 AS PROVIDED UNDER ANNEX "H" OF THE 2016 IRR OF R.A. 9184.
