EXECUTIVE ORDER NO. 02, s. 2019

AN ORDER FOR THE REORGANIZATION OF THE CITY ANTI-DRUG ABUSE COUNCIL (CADAC)

WHEREAS, the constitution mandates that the government shall promote the quality of life of the people;

WHEREAS, Section 16 of the Local Government Code of 1991, provides that the Local Government units shall pursue undertakings to improve public morals and maintain peace and order among equally significant issues;

WHEREAS, the increasing use of illegal drugs has significantly contributed to the incidence of crime;

WHEREAS, the problem of illegal drugs has to be addressed much more effectively to help ensure the community's safety, peace and order;

NOW THEREFORE, I, ATTY. CHRISTIAN D. NATIVIDAD, Mayor of the City of Malolos, by virtue of the powers vested in me by law, do hereby order the reorganization of City Anti-Drug Abuse Council (CADAC) which shall compose of the following:

Section 2. Duties and Functions

1. To formulate plans, programs and projects to suppress the use and sale of illegal drugs and identify related problems/issues which impede the implementation of such;
2. To strictly monitor barangays and particular areas, purok, sitios and plazas in coordination with barangay officials with suspected trade, sale and use of illegal drugs;
3. To coordinates with concerned non-government organizations and members of the private sectors for anti-drug campaign and to appropriate government agencies implementing the rules and laws against illegal drugs to apprehend violators; and
4. Prepares periodic reports upon execution of duties and functions assigned.

Section 3. Secretariat. There shall be a Secretariat headed by the Committee on Public Order and Security of the Sangguniang Panlungsod ng Malolos and shall perform the following:

1. Takes charge in the preparations of the council's meetings and prepares the minutes therefor;
2. Handles the administrative and technical activities of the Council;
3. Undertake liaising and coordination of activities; and
4. Takes custody of all documents concerning the Council without prejudice to its responsibility to furnish the Office of the City Mayor copy of the same documents when so requested.

Section 4. Meetings and Venue. The CADAC shall meet as often as necessary. Meetings shall be held in the Office of the Mayor unless otherwise specified by the Chairman or his duly authorized representative.

Section 5. Effectivity

This Executive Order shall take effect immediately upon approval.
