Executive Order No. 14 s. 2019

### AN EXECUTIVE ORDER PROVIDING THE IMPLEMENTATION PLAN FOR DILG MEMORANDUM CIRCULAR NO. 2019-121 AND CREATION OF TASK FORCE ON PUBLIC ROAD RECLAMATION

**WHEREAS**, President Rodrigo Roa Duterte during his 4<sup>th</sup> State of the Nation Address has directed all local government units to clear roads of illegal structures and constructions;

**WHEREAS**, the Department of Interior and Local Government articulated the directive of the President thru Memorandum Circular No. 2019-121 into a specific order;

**WHEREAS**, Section 32 of the Local Government Code prescribed supervision over barangays is vested in the power of the City and Municipal Mayors;

**WHEREAS**, Section 444 articulated the powers, duties, functions and compensation of Local Chief Executive:

*xxx b. (b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:*

*xxx (2) Enforce all laws and ordinances relative to the governance of the municipality and the exercise of its corporate powers provided for under Section 22 of this Code implement all approved policies, programs, projects, services and activities of the municipality and, in addition to the foregoing, shall:*

*xxx (i) Ensure that the acts of the municipality's component barangays and of its officials and employees are within the scope of their prescribed powers, functions, duties and responsibilities; xxx"*

**WHEREAS**, to ensure the implementation of reclamation of public roads, a Task Force on Public Road Reclamation is hereby created with the following composition and functions:

**NOW, THEREFORE, I, ENGR. GILBERT T. GATCHALIAN**, City Mayor of Malolos, Bulacan, by virtue of powers vested in me by existing and applicable laws do hereby order the following:

**SECTION 1. Composition**

**SECTION 2. Functions of Task Force on Public Road Reclamation**

- a. Set consultation meeting of all members of task force-PRR.
- b. Identify roads to be the object of clearing operations.
- c. Prepare road inventory.
- d. Prepare relocation plan for the affected and displaced individuals.
- e. Ensure human rights are being considered in demolition of structures and obstructions.
- f. Ensure safety of the people and public properties that may be affected of the clearing operations.
- g. Ensure that the implementation of this order are within the bound of laws.
- h. Monitor and evaluate the clearing initiatives of barangay.

- i. Prepare progress report.
- j. Submit Accomplishment Report to the Department of Interior and Local Government thru the City Local Government Operations Office.

**SECTION 4. Action Plan.** To ensure the immediate and proper implementation in compliance with the directives of the President of the Republic of the Philippines thru DILG Memorandum Circular No. 2019-121, an action plan was developed for this purpose.

**SECTION 3. Effectivity.** This Executive Order shall take effect immediately upon signing.
