Executive Order No. 16 s. 2019

AN EXECUTIVE ORDER RE-ORGANIZING THE MANILA BAY CLEAN-UP, REHABILITATION AND PRESERVATION CITY INSPECTION, INVENTORY AND MONITORING TEAM

WHEREAS, pursuant to the Local Government Code of 1991, particularly Section 465(b) (3) (v), Section 455 (b) (3) (vii), Section 444 (b) (3) (vii), Section 458 (a) (1) (vi) and Section 447 (a) (1), Provincial Governors, City Mayors, Municipal Mayors and Sanggunian Members at all levels are mandated to adopt adequate measures to safeguard and conserve land, mineral, marine, forest and other resources within their territorial jurisdiction and to protect the environment and impose appropriate penalties for acts which endanger the environment;

WHEREAS, in compliance with Supreme Court En Banc Decision dated December 2008 and En Banc Resolution dated February 15, 2011, all Provincial Governors, concerned Mayors of Cities and Municipalities within the Manila Bay area directed to organize the Manila Bay Clean-Up, Rehabilitation and Preservation Inspection, Inventory and Monitoring Team;

WHEREAS, the city issued Executive Orders No. 11 s. 2011 creating the Inspection, Inventory and Monitoring Team amended by Executive Order No. 18 s. 2013 and Executive Order No. 14 s. 2018 re-organizing the team;

NOW, THEREFORE, I, ENGR. GILBERT T. GATCHALIAN, City Mayor of Malolos, Bulacan, by virtue of powers vested in me by existing and applicable laws do hereby order the following:

Section 1. Composition. The Manila Bay Clean-up Rehabilitation and Preservation City Inspection, Inventory and Monitoring Team is composed of:

Section 2. Duties and Responsibilities

- a. Conduct inspection and inventories of all factories, commercial establishments and private homes within and outside the basement along shorelines and banks of major and minor river system and waterways within the city.
- b. Prepare and submit a duly certified list of the following
 - i. List of names and address of all non-complying factories, commercial establishments and private homes along the shorelines of and banks of major and minor river system and waterways within the city
 - ii. List of names and address of all private homes along the shorelines and banks of major and minor river system and waterways within the city
 - iii. List of names and address of informal settlers in their respective areas, who own or occupy houses, structures, constructions and other encroachments built along the shorelines and banks of major and minor river system and waterways within the city
- c. Monitor the compliance of non-complying factories, commercial establishments and private homes along the shorelines and banks of major and minor river system and waterways within the city
- d. Recommend the imposition of necessary actions and penalties to Local Chief Executive of all non-complying factories, commercial establishments and private homes along the shorelines and banks of major and minor river system and waterways within the city
- e. Preparation and submission of quarterly report on Key Performance Indicators (KPIs) compliance
- f. Perform other task that maybe assigned from time to time relative to the implementation of Manila Bay Clean Up Rehabilitation and Preservation Project

The City Local Government Operations Officer is hereby directed to provide the necessary technical assistance and monitor the compliance of this order.

Section 3. Effectivity. This Executive Order shall take effect immediately upon signing.
