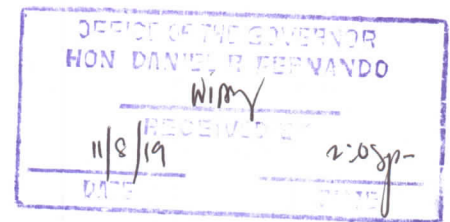

Executive Order No. 19 s. 2019

AN EXECUTIVE ORDER RECONSTITUTING THE CITY OF MALOLOS DEVELOPMENT COUNCIL (CMDC)

WHEREAS, as mandated in RA 7160 or the Local Government Code of 1991, there shall be a Local Development Council (LDC) organized as part of the Local Special Bodies in the Local Government Units (LGUs);

WHEREAS, there is already an existing Local Development Council (LDC) in the City of Malolos, Bulacan or the City of Malolos Development Council (CMDC), however, there is also this mandate to reconstitute or reformulate the membership during every term of the local chief executive;

WHEREAS, for this reason, a new set of members from the Civil Society Organizations (CSOs) were accredited anew and elected as members;

WHEREAS, the LGU of City of Malolos, recently done its duty and elected its CSO members in its local development council;

NOW, THEREFORE, I, GILBERT T. GATCHALIAN, City Mayor and Chairman of the Local Development Council of City of Malolos, Bulacan, by virtue of the power vested in me by existing and applicable laws do hereby order the:

SECTION 1. RECONSTITUTION OF THE CITY OF MALOLOS DEVELOPMENT COUNCIL (CMDC).

FUNCTIONS AND DUTIES. Consistent with the provision of the law, the CMDC shall:

1. Formulate long term, medium term, and annual socio-economic development plans and policies;
2. Formulate medium term and annual public investment programs;
3. Evaluate and prioritize socio-economic development programs and projects;
4. Formulate local investment incentives to promote the inflow and direction of private investment capital;
5. Coordinate, monitor and evaluate the implementation of development programs and projects; and
6. Perform such other functions as may be provided by law or competent authority.

SECTION 2. THE REORGANIZATION OF THE EXECUTIVE COMMITTEE (EXECOM) OF THE CMDC. The Local Development Council (LDC) shall, by resolution and within three (3) months from the date of the reorganization or reconstitution of the LDC, create an executive committee to represent and act in behalf of the LDC when it is not in session.

FUNCTIONS AND DUTIES. Consistent with the provision of the law, the CMDC shall:

1. Ensure that the directions of the CMDC are faithfully carried out and implemented.
2. Act on matters that need immediate attention and resolution of the CMDC.
3. Formulate policies, plans and programs based on the objective and priorities set by the CMDC.
4. Take final actions on the matters that may be authorized by the development plans and annual investment plans of the CMDC.

SECTION 3. THE REORGANIZATION OF THE SECTORAL OR FUNCTIONAL COMMITTEE. The Local Development Council may form sectoral or functional committees to assist them in the performance of their functions. The composition of the sectoral or functional committees of the CMDC are as follows:


