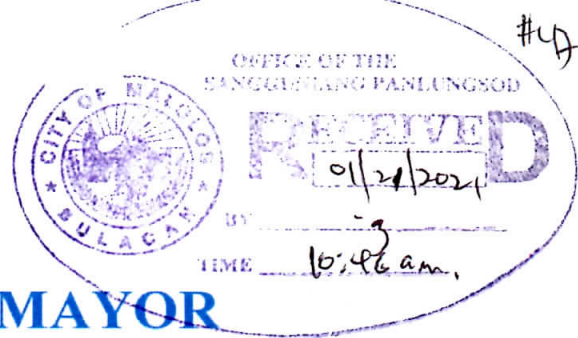

### EXECUTIVE ORDER NO. 01 Series of 2021

#### AN ORDER AMENDING SECTION I OF EXECUTIVE ORDER NO. 50 S. 2019 THE COMPOSITION OF THE CITY PEACE AND ORDER COUNCIL
