**Executive Order No. 22 s. 2019**

### **AN ORDER RECONSTITUTING THE PEOPLE'S LAW ENFORCEMENT BOARD IN THE CITY OF MALOLOS**

**WHEREAS**, by virtue of Republic Act No. 6975 and 8551, mandates the establishment of the People's Law Enforcement Board (PLEB) in every local government which serves as the central receiving entity for any citizen's complaint against any officers and members;

**WHEREAS**, NAPOLCOM Memorandum Circular No. 2016-002 or the Revised Rules of Procedure Before the Administrative Disciplinary Authorities and the Internal Affairs Service of the Philippine National Police defined the creation, functions and membership of PLEB;

**WHEREAS**, on July 25, 2019 the Sangguniang Panlungsod crafted City Resolution No. 105-2019, " A RESOLUTION ACKNOWLEDGING HON. ENRICO C. CAPULE AS THE REPRESENTATIVE OF THE SANGGUNIANG PANLUNGSOD TO THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) AND TO SERVE AS SUCH UNTIL THE END OF HIS TERM AS ELECTED COUNCILOR OF THE CITY OF MALOLOS";

**NOW, THEREFORE, I ENGR. GILBERT T. GATCHALIAN**, City Mayor of Malolos, Bulacan, by virtue of powers vested in me by existing and applicable laws do hereby order the following:

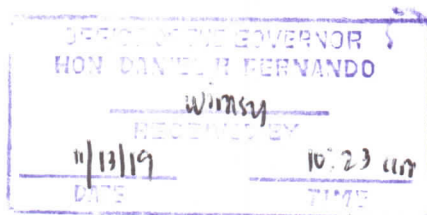

Chairman of PLEB will be elected among the members.

**Section 2. Functions, Powers and Duties.** The Board has the power to hear and adjudicate all citizen's complaints formally filed with, or referred to it, against any uniformed member of the PNP, and if warranted, impose the corresponding penalty.

**Section 4. Secretariat.** Designation of PLEB Secretariat Head, who should be at least be a degree holder of a plantilla position and have completed a Bachelor's Degree, to be determined by the City Mayor.

**Section 5. Effectivity.** This Executive Order shall take effect immediately upon signing.
