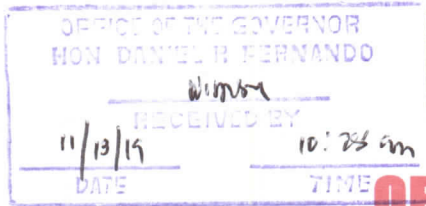

**Executive Order No. 26 s. 2019**

### **AN ORDER CREATING THE PEACE AND ORDER COUNCIL - SPECIAL ACTION COMMITTEE ON ANTI-INSURGENCY**

**WHEREAS**, Local Government of 1991 Section 16 mandates all local government units to ensure and maintain peace and order within their respective areas of jurisdiction;

**WHEREAS**, Section 116 of RA 7160 states that a peace and order council shall be established in every province, city and municipalities;

**WHEREAS**, Executive Order 773, series of 2009, entitled "Further Reorganizing the Peace and Order Council, Section 3 (b) states that Sub-National Councils shall identify strategies which will enrich peace and order and public safety within their respective areas of responsibility;

**WHEREAS**, Department of Interior and Local Government Memorandum Circular No. 2019-143, entitled Omnibus Guidelines for Peace and Order Councils (POCs) creation of **Special Action Committee on Insurgency**;

**NOW, THEREFORE, I ENGR. GILBERT T. GATCHALIAN**, City Mayor of Malolos, Bulacan, by virtue of powers vested in me by existing and applicable laws do hereby order the following:

**Section 1. Composition.** The Special Action Committee on Insurgency is composed of:

Chairperson	:	Highest Ranking AFP
Members:	:	Sangguniang Panlungsod Chairperson, Committee on Public Order and Safety City Local Government Operations Officer City Social Welfare and Development Officer City Chief of Police Other members, as maybe necessary

## **Section 2. Duties and Responsibilities**

1. Identify specific PPSAs that will prevent and counter insurgency
2. Identify the point persons or agencies who will take the lead for every anti-insurgency PPSAs identified
3. Propose cost of implementation, anticipated timeline, and other factors pertaining to the activities
4. Initiate and implement all ELCAC initiatives and all related activities
5. Frame each activity as part of a comprehensive approach
6. Submit identified anti-insurgency and ELCAC activities to the POPS Plan TWG for inclusion in the POPS Plan
7. Implement and monitor the POPS Plan funded PPSAs
8. Closely coordinate with POC Secretariat relative to the implementation of identified activities
9. Submit the following reports:
  - a. Semestral accomplishment report, submit not later than 15<sup>th</sup> day of August for 1<sup>st</sup> Semester and 15<sup>th</sup> day of March for the 2<sup>nd</sup> Semester
  - b. Annual Report not later than 15<sup>th</sup> day of March
10. Perform such other tasks as maybe directed by the council

**Section 3. Secretariat.** The committee shall designate a secretariat to support the implementation of this order.

**Section 4. Effectivity.** This Executive Order shall take effect immediately upon signing.
