Executive Order No. 27 s. 2019

AN ORDER CREATING THE PEACE AND ORDER COUNCIL - SPECIAL ACTION COMMITTEE ON PUBLIC SAFETY

WHEREAS, Local Government of 1991 Section 16 mandates all local government units to ensure and maintain peace and order within their respective areas of jurisdiction;

WHEREAS, Section 116 of RA 7160 states that a peace and order council shall be established in every province, city and municipalities;

WHEREAS, Executive Order 773, series of 2009, entitled "Further Reorganizing the Peace and Order Council, Section 3 (b) states that Sub-National Councils shall identify strategies which will enrich peace and order and public safety within their respective areas of responsibility;

WHEREAS, Department of Interior and Local Government Memorandum Circular No. 2019-143, entitled Omnibus Guidelines for Peace and Order Councils (POCs) creation of **Special Action Committee on Public Safety**;

NOW, THEREFORE, I ENGR. GILBERT T. GATCHALIAN, City Mayor of Malolos, Bulacan, by virtue of powers vested in me by existing and applicable laws do hereby order the following:

Section 1. Composition. The Special Action Committee on Public Safety is composed of:

Chairperson	:	Highest Ranking City Fire Officer
Members:	:	City Bureau of Jail Management and Protection Officer
		City Local Government Operations Officer
		City Health Officer
		City Disaster Risk and Reduction Management Officer
		Other members, as maybe necessary


Section 2. Duties and Responsibilities

1. Identify specific Public Safety Program (PSPs) other related activities
2. Identify the point persons or agencies who will take the lead for every PSP identifies
3. Propose cost of implementation, anticipated timeline, and other factors pertaining to the activities
4. Frame each activity as part of a comprehensive approach
5. Submit identified PSPs to the POPS Plan TWG for in the POPS Plan
6. Implement and monitor the PSPs funded in the POPS Plan
7. Closely coordinate with POC Secretariat relative to the implementation of identified activities
8. Submit the following reports:
 - a. Semestral accomplishment report, submit not later than 15th day of August for 1st Semester and 15th day of March for the 2nd Semester
 - b. Annual Report not later than 15th day of March
9. Perform such other tasks as maybe directed by the council

Section 3. Secretariat. The committee shall designate a secretariat to support the implementation of this order.

Section 4. Effectivity. This Executive Order shall take effect immediately upon signing.
