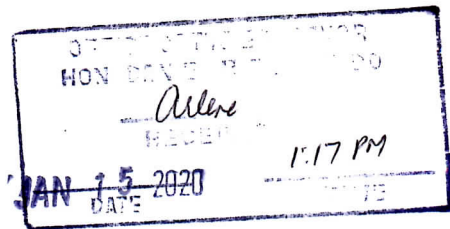

Executive Order No. 02, s. 2020

### “AN EXECUTIVE ORDER RECONSTITUTING THE HUMAN RESOURCE MERIT PROMOTION AND SELECTION BOARD (HRMPSB) OF THE CITY GOVERNMENT OF MALOLOS

**WHEREAS**, Section 80 (b) of Republic Act 7160, otherwise known as the Local Government Code of 1991 states that *“There shall be established in every province, city or municipality a personnel selection board to assist the local chief executive in the judicious and objective selection of personnel for employment as well as for promotion, and in the formulation of such policies as would contribute to employee welfare”*;

**WHEREAS**, the Personnel Selection Board (PSB) of the City Government of Malolos was continuously reconstituted/re-established to provide assistance to the appointing authorities in the recruitment, selection and promotion of city government personnel;

**WHEREAS**, Rule IX, Section 88 of Civil Service Commission (CSC) Memorandum Circular No. 24 s. 2017 dated August 24, 2017, “2017 Omnibus Rules on Appointments and Other Human Resource Actions adopted and promulgated through CSC Resolution No. 1701009 dated June 16, 2017 requires for the creation of the Human Resource Merit Promotion and Selection Board (HRMPSB);

**WHEREAS**, there is an essential need to establish the HRMPSB to comprehensively respond to updated personnel recruitment, selection and promotion process in the city government;

**NOW THEREFORE, I, ENGR. GILBERT T. GATCHALIAN**, City Mayor of Malolos, Bulacan, by virtue of the authority vested in me by law, hereby order the reconstitution of the Human Resource Management Promotion and Selection Board (HRMPSB) of the City Government of Malolos as follows:
