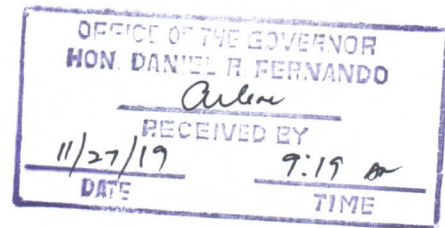

Executive Order No. 31 s. 2019

“AN ORDER CREATING THE SCHOLARSHIP BOARD IN THE CITY GOVERNMENT OF MALOLOS”

WHEREAS, Article XIV of the Constitution provides that “the State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all”;

WHEREAS, the City Government of Malolos is one with the National Government in providing scholarship grants to underprivileged but deserving students for improvement of their social and economic standing that will further lead to the development of the City;

WHEREAS, the Sangguniang Panlungsod of Malolos passed City Ordinance No. 41-2018 “An Ordinance Institutionalizing the Scholarship Program of the City of Malolos and Appropriating Funds Therefor”;

NOW THEREFORE, I, ENGR. GILBERT T. GATCHALIAN, City Mayor of Malolos, Bulacan, by virtue of the power vested in me, do hereby order:
