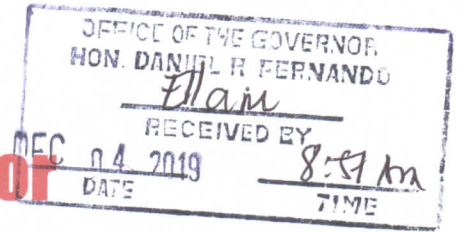

Executive Order No. 33 s. 2019

“AN ORDER REORGANIZING THE SOLID WASTE MANAGEMENT BOARD IN THE CITY GOVERNMENT OF MALOLOS”

WHEREAS, it is the policy of the State to protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;

WHEREAS, Republic Act No. 9003, otherwise known as the Ecological Solid Waste Act 2000, declared as policy of the State to adopt a systematic, comprehensive and ecological solid waste management program;

WHEREAS, the city recognizing its role, has exerted efforts in setting guidelines for adoption of environmental practice in ecological waste management;

WHEREAS, DILG Memorandum Circular No. 2004 – 151 mandates the necessity to keep the membership of the Local Solid Waste Management Board;

NOW THEREFORE, I, ENGR. GILBERT T. GATCHALIAN, City Mayor of Malolos, Bulacan, by virtue of the power vested in me by law, do hereby order:

Section 2. **DUTIES AND FUNCTIONS OF THE
CITY SOLID WASTE MANAGEMENT BOARD (CSWMB)**

- a. Develop the City Solid Waste Management Plan that shall ensure long-term management of solid waste, as well as to the integration of solid waste management plan and strategies of all barangays in the City of Malolos, with the participation of various sectors of the community;
- b. Adopt measures to promote and ensure the viability and effective implementation of solid waste management programs in its component barangays;
- c. Monitor the implementation of the City Solid Waste Management Plan through its various political subdivisions in cooperation with the private sectors and NGOs;

- d. Adopt a specific revenue generating measures to promote the viability of the City's Solid Waste Management Plan;
- e. Convene regular meetings for purposes of planning and coordinating the implementation of the Solid Waste Management Plans of respective barangays;
- f. Oversee the implementation of the Solid Waste Management Plan;
- g. Review every two years or as the need arises the Solid Waste Management Plan to ensure sustainability, viability, effectiveness and relevance in relation to local and international developments in the field of solid waste management;
- h. Develop specific mechanics and guidelines for the implementation of Solid Waste Management Plan;
- i. Recommend to appropriate local authorities' specific measures or proposals for franchise or build-operate-transfer agreements with duly recognized institutions, pursuant to RA 6957, to provide either exclusive or non-exclusive authority for the collection, transfer, storage, processing, recycling or disposal of city solid waste. The proposals shall take into consideration appropriate government rules and regulations on contracts, franchise and build-operate transfer agreements;
- j. Provide necessary logistical and operational support to its component barangays;
- k. Perform such other functions as may be provided by law or competent authority.

Section 3. CSWMB SECRETARIAT

The Office of the City Administrator shall act as the secretariat of the City Solid Waste Management Board.

Section 4. EFFECTIVITY

This order shall take effect immediately.
