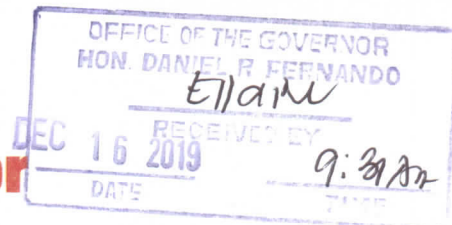

Executive Order No. 35 s. 2019
“AN ORDER CREATING THE CITY OF MALOLOS HERITAGE CONSERVATION
TECHNICAL WORKING GROUP”

WHEREAS, Section 16 Title 1 of the Local Government Code of 1991 provides that local government units within their respective territorial jurisdictions shall ensure and support the preservation and enrichment of culture;

WHEREAS, Section 2 of the City Ordinance No. 72 – 2017 otherwise known as “City of Malolos Heritage Preservation Ordinance” provides that as a matter of public policy the protection, enhancement, and perpetuation of areas and landmarks of historical and cultural importance and significance is necessary to promote the economic, cultural, educational and general welfare of the public;

WHEREAS, Section 4 of the City of Malolos Heritage Preservation Ordinance created an office to be known as the City of Malolos Heritage Administrative Authority;

WHEREAS, In order to compliment the City of Malolos Heritage Administrative Authority, it is necessary to create a Technical Working Group that shall study, evaluate and formulate policies concerning the historical and cultural properties and resources within the City of Malolos;

NOW THEREFORE, I, ENGR. GILBERT T. GATCHALIAN, City Mayor of the Malolos, Bulacan, by virtue of the power vested in me do hereby order:
