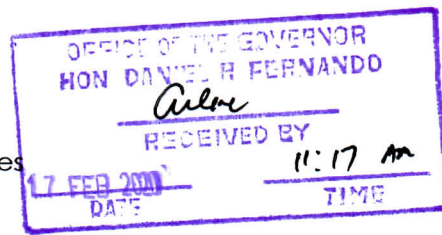

#### AN ORDER AMENDING EXECUTIVE ORDER NO. 34 s. 2019 ENTITLED “AN ORDER ENJOINING THE RECONSTITUTION OF THE CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (CDRRMC) IN THE CITY GOVERNMENT OF MALOLOS”


