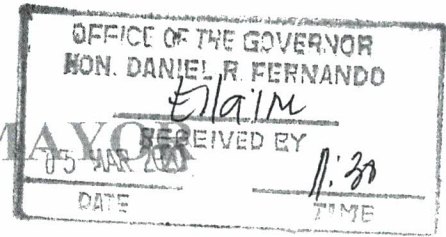

**“AN ORDER AMENDING EXECUTIVE ORDER NO. 8 s. 2020 OF THE CITY
DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (CDRRMC) IN THE
CITY GOVERNMENT OF MALOLOS.”**

WHEREAS, the CDRRMC during its first quarterly meeting on 11th day of February 2020 proposed amendments to the composition of the membership of the council was raised and duly seconded by the members.

WHEREAS, after further consultation with various stakeholders, the council was advised to create a technical working group (TWG) for the development of programs and plans to be implemented by all government agencies concerned with the Disaster Planning, Adaptation and Mitigation.
