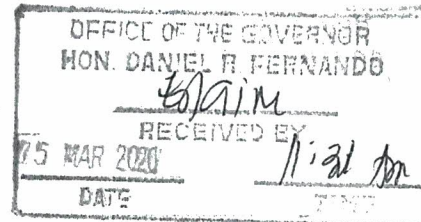

EXECUTIVE ORDER NO. 15 Series of 2020

AN ORDER ORGANIZING THE RETOOLED COMMUNITY SUPPORT PROGRAM (RSCP) TEAM AND CORE TEAM OF THE CITY OF MALOLOS, BULACAN

WHEREAS, President Rodrigo Roa Duterte issued the Executive Order NO. 70 last 04 December 2018 entitled “institutionalizing the Whole-of-Nation approach in attaining inclusive and sustainable peace, creating the National Task Force to End Local Communist Armed Conflict, and directing the adoption of a National Peace Framework” (EO 70);

WHEREAS, the Community Support Program (CSP) is a program of the Armed Forces of the Philippines (AFP) Development Support and Security Plan (DSSP) dubbed as “Kapayapaan” which is multi-stakeholder and community-based peace and development effort aimed to establish and protect a conflict-affected community. The CSP aims to identify issues of the communities and introduce developmental interventions to resolve these issues that community itself identified. However, the CSP is limited with resources in addressing issues and gaps due to limited resources and participation of other National Government Agencies. (NGA);

WHEREAS, the Retooled Community Support Program (RSCP) is an inclusive program that aims to address identified issues of the community by closing the governance and development gaps through provision needed government PPAs while ensuring that development is sustained and peace is being promoted;

WHEREAS, the RSCP is a convergence mechanism of LGUs particularly in the barangay for the identification of issues of the community and needed government interventions. It is anchored on the empowerment framework that intends to develop people’s capability to organize themselves and own development by bringing about value-chain interventions to uplift their current condition;

WHEREAS, DILG Memorandum Circular No. 2019-169 provides for the Guidelines on the implementation of the Retooled Community Support Program (RCSP);

NOW THEREFORE, I GILBERT T. GATCHALIAN, City Mayor of Malolos, Bulacan, by the powers vested in me by law, do hereby organize the Retooled Community Support Program (RSCP) Team and Core Team of the City of Malolos, as follows;

SECTION 1. *Composition and Functions of Retooled Community Support Program (RCSP) Team and Core Team.* The RCSP TEAM of the City of Malolos, Bulacan is hereby created as follows:

Chairperson: **ENGR. GILBERT T. GATCHALIAN**

Vice Chairperson: **MR. FRANCISCO S. DOMINGO JR.**
City Administrator

The Local Chief Executive (LCE) shall serve as the Head of the Task Team and shall champion the cause to be the forefront of the stride of bringing the needed government interventions to the people through RCSP. The head shall also be in-charge with the deployment of the RCSP Team to the target barangay for immersion and ensure that development initiatives are properly delivered, immediate needs properly addressed, and long-term needs are properly programmed for founding and implementation.

The City Development Council and City Peace and Order Council shall maintain a vital linkage to the RCSP task Team for the purpose of programs and projects coordination. The councils shall focus on screening and prioritizing needed government interventions that must be included as priority in the Local Development Investment Program (LDIP). Furthermore, the RCSP Team must also ensure the identified PPAs shall be implemented by securing available funding under all available sources from both national and local government sources.

SECTION 2. *Duties and Responsibilities*

2.1 Basic Service Delivery Team

2.1.1 The BSDT is the team tasked to serve as the primary bridge of RCSP Team to the National Government.

2.1.2 The configuration and additional membership of the BST from ELCAC Technical Working Group (TWG) Lines of Effort and other concerned agencies that may be identified as deemed

necessary, shall be determined by the RCSP core team and shall depend upon the issues identified by the community during the profiling and/or based on the results of the Social Investigation Class Analysis (SICA) data from Community Based Monitoring System (CBMS), Governance Audit Reports (GAR) Geographically Isolated and Disadvantage Areas (GIDA), information from previous CSP immersions.

2.1.3 Others that may be identified.

2.2 Citizenship and Community Participation Team

2.2.1 The CCPT is tasked to organize the Citizenship Movement by mobilizing communities into sectoral groups and usher them to participate in all sectoral dialogues/solution seeking tables aimed to validate the governance and development gaps of the communities and identify the needed government interventions to address them.

2.2.2 Others that may be identified.

2.3 Peace, Law Enforcement and Development Support Team

2.3.1 The PLEDS Team is tasked to conduct clearing operations one week prior to the actual send-off of the RCSP Team, ensure perimeter security of the target-Barangay during the entire duration of the immersion, and continuous sanitation of the community from terrorist threats during the implementation and provision of needed government interventions.

2.3.2 Ensure the safety of the RCSP Team during the immersion, the team head all advice of the representative from the AFP pertaining to the security protocols including proper approach and withdrawal to and from barangay and after the immersion.

2.4 RCSP Core Team

2.4.1 Shall serve as the unit that directly provides all the necessary tactical, technical, logistical and administrative assistance to the Local Chief Executive in the performance of its function as RCSP Head.

2.4.2 Once all the target barangays for the year are identified and the representative RCSP teams identified and organized, the RCSP Core team shall undergo RCSP Training and simulation exercise prior to the send-off ceremony and actual immersion. The training shall be spearheaded by the Local Government Academy in partnership of the DILG Regional Office.


2.4.3 Others that may be identified.

SECTION 3. *Repealing Clause.* All orders, issuances and memorandum issued inconsistent herewith are hereby repealed or modified accordingly.

SECTION 4. *Separability Clause.* If for any reason any portion or provision of this Executive Order is declared unconstitutional or invalid, the other sections or provision thereof which are not affected shall continue to be in full force and effect.

SECTION 5. *Effectivity.* This Executive Order shall take effect immediately.
