**AN ORDER AMENDING THE EXECUTIVE ORDER NO. 18, s. 2020 ENTITLED, "AN ORDER RECONSTITUTING THE BUSINESS PERMIT AND LICENSING SYSTEM TECHNICAL WORKING GROUP (BPLS-TWG) AND THE JOINT INSPECTION TEAM (JIT) OF THE CITY OF MALOLOS"**
