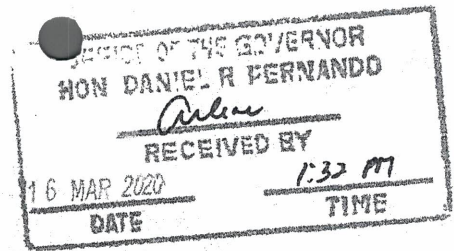

EXECUTIVE ORDER NO. 20 Series of 2020

AN ORDER CREATING AND ORGANIZING THE CITY OF MALOLOS CONSUMER'S PROTECTION COUNCIL (CMCPC).

WHEREAS, under Republic Act 7394, otherwise known as the "Consumer Act of the Philippines," it is the policy of the State to protect the interest of the consumer, promote his general welfare and to establish standards of conduct for business and industry;

WHEREAS, under the Consumer Act of the Philippines, the State shall implement measures to protect the consumer against deceptive, unfair and unconscionable sales acts and practices;

WHEREAS, on 16 March 2018, the then City Mayor Atty. Christian D. Natividad signed the Kautusang Panlungsod Blg. 15-2018 entitled "ISANG KAUTUSANG PANLUNGSOD NA NAGTATATAG AT LUMILIKHA SA CITY OF MALOLOS CONSUMER'S PROTECTION COUNCIL (CMCPC), PRICE WATCH COMMITTEE (PWC) PAGBABALANGKAS NG MGA GAMPANIN NITO, PAGLALAN NG PONDO HINGGIL DITO AT PARA SA IBANG LAYUNIN" created the City of Malolos Consumer's Protection Council o CMPC tasking the same council to create a Price Watch Committee;

NOW, THEREFORE, I, ENGR. GILBERT T. GATCHALIAN, City Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by law, do hereby order:

The Head of the Business Permit and Licensing Office – Atty. Aida S. Bernardino is hereby declared to be one of the members of the City of Malolos Consumer’s Protection Council.

SECTION II. DUTIES AND FUNCTIONS OF THE COUNCIL. The Duties and Functions of the Council shall be those enumerated under Section 4 of Kautusang Panlungsod Blg. 15 – 2018.

SECTION III. SECRETARIAT. The Business Permit and Licensing Office shall act as the Secretariat of the Council.

SECTION IV. CREATION OF THE PRICE WATCH COMMITTEE. The Council shall create a Price Watch Committee from its members that shall be comprised of not less than 3 nor more than 5 members of the Council.

SECTION V. DUTIES AND FUNCTIONS OF THE PRICE WATCH COMMITTEE:

SECTION V. DUTIES AND FUNCTIONS OF THE PRICE WATCH COMMITTEE:

1. Monitor prices of goods being sold at the Malolos Public Market and all other *talipapa* in the City.
2. Maintain a Price Watch Bulletin at the Malolos Public Market, and other *talipapa*, whenever applicable.

SECTION VI. EFFECTIVITY. This Executive Order shall take effect immediately upon signing.
