

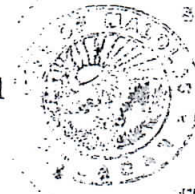

AN ORDER REQUIRING THE OBSERVANCE OF STRICT HOME QUARANTINE AND THE CLOSURE OF ESTABLISHMENTS PROVIDING NON-BASIC NECESSITIES AND SERVICES OTHER THAN THOSE PERMITTED TO BE OPENED UNDER THE MEMORANDUM FROM THE EXECUTIVE SECRETARY OF THE OFFICE OF THE PRESIDENT DATED 16 MARCH 2020.

WHEREAS, the Memorandum from the Executive Secretary Atty. Salvador C. Medialdea dated 16 March 2020 placed the entire Luzon under an Enhanced Community Quarantine effective 12 a.m of 17 March 2020 until 12 a.m. of 13 April 2020;

WHEREAS, Item 3 of the abovementioned Memo provides that, "A strict home quarantine shall be observed in all households;"

WHEREAS, Item 5 Paragraph 1 of the same Memo enumerated the establishments that shall remain in operation notwithstanding the Enhanced Community Quarantine;

NOW, THEREFORE, I, ENGR. GILBERT T. GATCHALIAN, City Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by law, do hereby order:

OBSERVANCE OF STRICT HOME QUARANTINE. All Constituents of the City of Malolos are required to observe home quarantine except employees of the City Government who are part of the skeletal workforce to render public service, and all individuals whose services are required in order to continue the operations of the establishments mentioned under Item 5 Paragraph 1 of the Memorandum from the Executive Secretary, to wit: private establishments providing basic necessities and such activities related to food and medicine production, i.e., public markets, supermarkets, groceries, convenience stores, hospitals, medical clinics, pharmacies and drug stores, food preparation and delivery services, water-refilling stations, manufacturing and processing plants of basic food products and medicines, banks, money transfer services, power, energy, water and telecommunications supplies and facilities.

TEMPORARY CLOSURE OF NON-ESSENTIAL ESTABLISHMENTS. - All establishments not included in the enumeration mentioned under the immediately preceding paragraph are hereby ordered temporarily closed effective immediately until 13th of April, 2020.

This Executive Order shall take effect immediately upon signing thereof.
