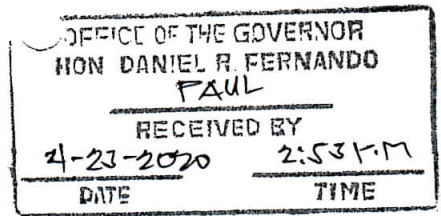

EXECUTIVE ORDER NO. 26 Series of 2020

AN ORDER CREATING THE CONTACT TRACING TEAM FOR THE COVID-19 PANDEMIC OF THE CITY OF MALOLOS

WHEREAS, under Proclamation No. 922 dated 8 March 2020, the President of the Republic of the Philippines, President Rodrigo Roa Duterte declared a State of Public Health Emergency throughout the Philippines due to COVID – 19;

WHEREAS, on 13 April 2020, the Department of the Interior and Local Government issued Memorandum Circular No. 2020-073, the subject of which provides Guidelines for the Conduct of the Expanded Testing Procedures for Covid-19;

WHEREAS, DILG Memorandum Circular 2020-073 has directed each local government unit to organize a Contact Tracing Team;

WHEREAS, pursuant to Section 455, (2) (iii) of the Local Government Code of 1991, the City Mayor as the Chief Executive of the city government has the power to issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

NOW THEREFORE, I, ENGR. GILBERT T. GATCHALIAN, City Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by law, do hereby order:

SECTION I. CREATION OF THE CONTACT TRACING TEAM OF THE CITY GOVERNMENT OF MALOLOS. The following shall comprise the Contact Tracing Team of the City Government of Malolos:

SECTION II. FUNCTIONS OF THE CONTACT TRACING TEAM

1. Conduct contact tracing for all persons with known exposure to a COVID-19 patient to ensure their strict observance of home quarantine measures;
2. Monitor the status of Person Under Investigation (PUI), Person Under Monitoring (PUM), family members with known contact to a confirmed case to mitigate possibility of contagion;
3. Submit daily updates to the COVID-19 Provincial and Regional Task Forces.
4. Perform other functions as may be necessary.

SECTION III. EFFECTIVITY. This Executive Order shall take effect immediately upon signing thereof.
