

EXECUTIVE ORDER NO. 27
Series of 2020

AN ORDER PROVIDING FOR THE IMPLEMENTATION OF STRICTER MEASURES WITHIN THE CITY OF MALOLOS DURING THE EXTENSION OF THE ENHANCED COMMUNITY QUARANTINE.

WHEREAS, under Proclamation No. 922 dated 8 March 2020, the President of the Republic of the Philippines, President Rodrigo Roa Duterte declared a State of Public Health Emergency throughout the Philippines due to COVID-19;

WHEREAS, under the Memorandum from the Executive Secretary dated 16 March 2020, the Executive Secretary Salvador C. Medialdea by Order of the President provided guidelines on the imposition of an Enhanced Community Quarantine and on Stringent Social Distancing Measures over the entire Luzon;

WHEREAS, on 17 March 2020, this Office has issued Executive Order No. 21 that orders the observance of strict home quarantine within the City of Malolos;

WHEREAS, on 13 April 2020, this Office has issued Executive Order No. 24 that extended the observance of strict home quarantine within the City pursuant to the Memorandum of the Executive Secretary signed on 7 April, 2020 which extended the Enhanced Community Quarantine over the entire Luzon until 30 April 2020;

WHEREAS, on 25 April 2020, the Inter-Agency Task Force for the Management of Emerging Infectious Disease (IATF) had a conference during which the Presidential Spokesperson announced the extension of the Enhanced Community Quarantine in Metro Manila, Central Luzon, Calabarzon and other "high risk" areas in the Philippines;

WHEREAS, pursuant to Section 455, (2) (iii) of the Local Government Code of 1991, the City Mayor as the Chief Executive of the city government has the power to issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;



NOW THEREFORE, I, ENGR. GILBERT T. GATCHALIAN, City Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by law, towards ensuring the strict observance of the Enhanced Community Quarantine within the City, do hereby order:

SECTION I. STRICT OBSERVANCE OF HOME QUARANTINE. In order to mitigate proliferation of the COVID-19, the following policies are hereby enforced:

1. ISSUANCE OF A NEW QUARANTINE PASS BY THE OFFICE OF THE CITY MAYOR. Home quarantine passes and market passes issued by the Barangay government to the Heads of Household, and special market passes issued by the City Government to owners of registered food businesses are now declared of no force and effect. A new general quarantine pass shall be issued per household. Recipients of quarantine passes who shall be atleast 18 years of age shall be assigned by their family members.

All establishments within the City of Malolos including the Malolos Public Market shall honor the new quarantine pass. Only individual holders of a quarantine pass are allowed to set foot outside the confines of their own houses to buy essential goods and conduct transactions with essential establishments.

- 2. TWO-DAY WINDOW PERIOD. The new quarantine pass authorizes its bearer to go out of his residence only twice a week.
 - 2.1 The 51 barangays of the City shall be clustered into 3 clusters in the following manner:
 - Constituents who reside at Barangays included in the First Cluster are allowed to go out only during Mondays and Thursdays;
 - Constituents who reside in the Second Cluster are allowed to go out only during Tuesdays and Fridays; and
 - Constituents who reside in the Third Cluster are allowed to go out only during Wednesdays and Saturdays.

Attached hereto as an Annex is the Clustering of Barangays.

- 3. MANDATORY WEARING OF FACE MASK. All persons going out of their residence are required to wear face masks.
- 4. NO HOME QUARANTINE PASS, NO TRANSACTION POLICY. Essential establishments are hereby required to cater only to clients with Quarantine Pass. In the case of establishments with which transactions are not permitted to be done by a representative such as banks and money transfer services, a travel pass bearing the establishment to be visited, the date of visit, and the purpose of the said visit issued by the Office of the City Mayor shall be presented in case the person who intends to make the transaction is not issued a Home Quarantine Pass.
- 5. COMPULSORY ISOLATION OF PERSONS DETERMINED TO BE COVID-19 SUSPECTS BY THE CITY CONTACT TRACING TEAM. All persons determined by

the Contact Tracing Team of the City of Malolos to have had contact with a COVID-19 positive patient who are symptomatic shall be required to undergo isolation for at least 14 days at a designated isolation facility by the City Government unless the COVID-19 suspect can be isolated at a particular room in his home.

The Members of the PNP in coordination with the City Health Office and the City Disaster Risk Reduction Management Office are hereby authorized to bring COVID-19 suspects to isolation facilities upon presentation to COVID-19 suspects of the documentation that contain the contact tracing results.

The PNP is hereby further authorized to cause the filing of the appropriate case against non-cooperating PUI Suspects in relation to Republic Act 11332, otherwise known as the "Mandatory Reporting of Notifiable Diseases and Health Events of Public Health Concern Act".

- 6. MANDATORY REPORTING TO THE BARANGAY OFFICIALS OF ALL BALIKBAYANS. Any person who shall arrive to the City of Malolos from another country within 14 days of his arrival to the Philippines shall not be allowed entry to the City without presenting a quarantine clearance from the Bureau of Qurantine or the Department of Health to the checkpoints located at the boarders of the City of Malolos. Once permitted entry, he shall immediately proceed to the Office of the Punong Barangay of the barangay where he desires to stay in order for the Barangay Officials to ensure that he shall be isolated for another 14 days before reintegration to community.
- 7. SUNDAY AS THE DESIGNATED DAY FOR DISINFECTION. Only Hospitals, Health Clinics, Lying-in Clinics, and Pharmacies are allowed to operate on a Sunday. All other establishments are prohibited to operate during Sundays.

SECTION II. PENALTIES. Any person who shall violate any of the policies in this Executive Order shall be apprehended by the members of the PNP and shall be brought to the holding areas designated by the City Government for this purpose. First time offenders shall be made to perform community service. Repeat Offenders shall be dealt with more severely which may include the filing of the appropriate criminal case within 12 hours from the time of their apprehension. In case the violator is an establishment, its owner, president, or manager, shall be held answerable to the City Government.

SECTION III. EXCEPTIONS. Only healthworkers, frontliners, force multipliers duly accredited by the City Government, essential government employees, and employees of essential establishments, in the performance of their duties, and elected public officials, are exempt from the operation of the Two-day window period.

With regard to elected barangay officials, only the Punong Barangays and Barangay Kagawads are allowed to go out of their areas of jurisdiction outside the applicable Two-day window period in their barangay; while Barangay Volunteers (Lingkod Lingap sa Nayon, Lingkod Lingap sa Pamilya, Barangay Health Workers, Mother Leaders, and Barangay Tanods)

are allowed to go out only within their respective Barangays outside the applicable Two-day window period.

Individuals covered under exemptions to the enhanced community quarantine regulations issued by the Inter-Agency Task Force for the Management of Emerging Infectious Disease, and other National Agencies shall be honored by the City Government.

In case of individuals not covered under any exemption who are constituents of other local government units, they shall be allowed entry to the City of Malolos upon presentation of a travel pass signed by their local chief executive or his authorized representative, provided the purpose of entry to the City of Malolos shall be limited to visits to hospitals, banks with which the non-resident has an account, and government agencies.

In all cases, exempt individuals shall present proof, such as but not limited to identification cards, physician's prescription, or documents which supports the exemption given hereunder.

SECTION IV. SEPARABILITY CLAUSE. Should any provision of this Executive Order or any part thereof be declared invalid, the other provisions, insofar as they are separable from those declared invalid, shall remain in full force and effect.

SECTION IV. EFFECTIVITY. This Executive Order shall take effect immediately upon signing thereof.
