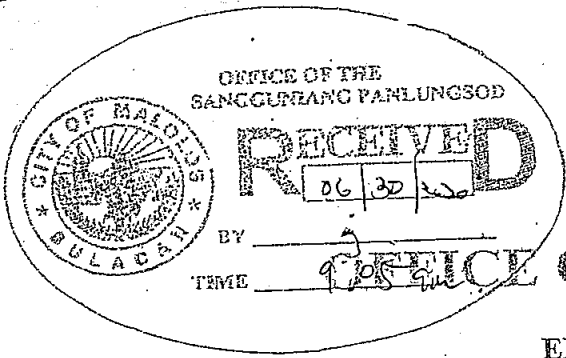
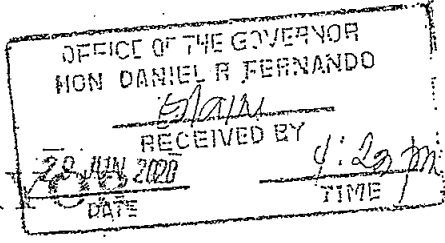

AN ORDER CREATING THE INVESTIGATION COMMITTEE ON THE ALLEGED IRREGULARITIES ON THE REQUIREMENTS FOR THE ISSUANCE OF TRAVEL AUTHORITY-

WHEREAS, pursuant to the 1987 Constitution of the Republic of the Philippines, public officers and employees must, at all times, be accountable to the people, serve them with utmost responsibility, integrity, loyalty, and efficiency;

WHEREAS, the City Government of Malolos strongly condemns any and all acts of dishonesty and corruption as it strive to serve the Malolenyos with the level of public service the constituents of the City deserve;

WHEREAS, on 20 June 2020, an article was published that referred to the requirements prior to issuance of a travel authority by the City One-Stop Shop dedicated for the issuance of a travel authority as a "scam";

WHEREAS, pursuant to Section 455, (2) (iii) of the Local Government Code of 1991, the City Mayor as the Chief Executive of the city government has the power to issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

NOW THEREFORE, I, ENGR. GILBERT T. GATCHALIAN, City Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by law, do hereby order:

SECTION I. CREATION OF THE INVESTIGATION COMMITTEE IN CONNECTION TO THE ALLEGED IRREGULARITIES AT THE ONE-STOP SHOP. There shall be created an Investigation Committee that shall investigate on the veracity of the contents of the article penned by Mr. Orlan Mauricio dated 20 June 2020. The Investigation Committee shall be comprised of:

- CHAIRMAN** : The City Legal Officer
- CO - CHAIRMAN** : The City Local Government Operations Officer
- MEMBERS** : The City Administrator
- The Sangguniang Panlungsod Chairman of the Committee on Ethics and Good Government

SECTION II. FUNCTIONS. The Investigation Committee shall investigate on the issuance of travel authorities at the One-Stop Shop in order to determine whether or not employees of the city government has committed acts in violation of the Republic Act 6713 otherwise known as "Code of Conduct and Ethical Standards for Public Officials and Employees", or has connived with any public or private entity in order to financially benefit from the transactions at the One Stop Shop.

SECTION III. EFFECTIVITY. This Executive Order shall take effect immediately upon signing thereof.
