

EXECUTIVE ORDER NO. 36 Series of 2020

AN ORDER PROVIDING FOR THE IMPLEMENTATION OF MEASURES THAT SHALL BE OBSERVED WITHIN THE CITY OF MALOLOS DURING THE MODIFIED GENERAL COMMUNITY QUARANTINE

WHEREAS, under Proclamation No. 922 dated 8 March 2020, the President of the Republic of the Philippines, President Rodrigo Roa Duterte declared a State of Public Health Emergency throughout the Philippines due to COVID - 19;

WHEREAS, under the Memorandum from the Executive Secretary dated 16 March 2020, the Executive Secretary Salvador C. Medialdea by Order of the President provided guidelines on the imposition of an Enhanced Community Quarantine and on Stringent Social Distancing Measures over the entire Luzon;

WHEREAS, on 30 June 2020, the President of the Philippines approved the recommendation of the Inter-Agency Task Force for the Management of Emerging Infectious Diseases, which placed the Province of Bulacan under the quarantine classification of Modified General Community Quarantine beginning 1 July 2020 until 15 July 2020;

WHEREAS, it is the policy of the State to protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, the Local Government Code mandates the local government units to exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, pursuant to Section 455, (2) (iii) of the Local Government Code of 1991, the City Mayor as the Chief Executive of the city government has the power to issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

NOW THEREFORE, I, ENGR. GILBERT T. GATCHALIAN, City Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by law, towards promotion of the General Welfare within the City, do hereby order strict observance of the following policies and



measures for the entire period that the City of Malolos is placed under the Modified General Community Quarantine classification:

SECTION I. PERSONS ALLOWED OUTSIDE OF RESIDENCE. Except for instances allowed under the IATF-EID Guidelines, only persons between the ages of 21 and 59 are allowed to go outside of their residences.

SECTION II. MINIMUM PUBLIC HEALTH STANDARDS SHALL BE COMPLIED WITH AT ALL TIMES.

- MANDATORY WEARING OF FACE MASKS. The mandatory wearing of face masks shall-be observed at all times. No person shall be allowed to step out of his residence without wearing a face mask.
- OBSERVANCE OF SOCIAL DISTANCING AND MANDATORY CHECK OF TEMPERATURE. The management of all establishments, institutions, and public and private offices (referred to herein as "establishments" for brevity), are enjoined to implement social distancing through implementation of measures that ensure at least 1
 meter of distance between two individuals at all times. It shall also be mandatory to check the temperature of all the employees, clients, and visitors therein.
- 3: OBSERVANCE OF PHYSICAL DISTANCING FOR PUBLIC AND PRIVATE VEHICLES. All owners and drivers of public and private vehicles are mandated to observe the passenger limit and maintain sufficient distance between the passengers as provided by the Department of Transportation.
- 4. **REGULAR DISINFECTION**. The management and owners of all establishments shall implement regular disinfection.

SECTION III. LIFTING OF QUARANTINE PASS REQUIREMENT, WINDOW PERIOD AND CLUSTERING. The window period and Clustering of barangays is hereby lifted. Non-residents of Malolos may now enter supermarkets, groceries and malls within the City.

SECTION IV. MARKET SCHEDULE AND POLICY. The Malolos Public Market shall continue to implement clustering or two - day window period. Although quarantine pass is no longer required, it may be used to prove residency in a particular barangay in the absence of an identification card or barangay residency certificate.

Malolos Public Market shall operate from 5:00 AM until 5:00PM.

SECTION V. SECTORS OR INDUSTRIES ALLOWED TO OPERATE. Pursuant to the IATF-EID guidelines, all categories of establishments and activities allowed under the GCQ classification are now allowed to operate or to be undertaken at full operational capacity subject to following limitations:

a. Barber Shops, salons, and other personal care service establishments, at a maximum of fifty percent (50%) of venue capacity;

- b. Dine in restaurants, fast food and food retail establishments, including those in supermarkets, grocery stores, and food preparation establishments, at a maximum of fifty percent (50%) of seating capacity;
- c. Category IV and all other establishments previously not permitted to operate are now allowed to operate at a 50% operational capacity. However, for hotels and other accommodation establishment, only those with Certificate of Authority to operate from the Department of Tourism may be allowed to operate.

SECTION VI. WORK IN GOVERNMENT OFFICES. Pursuant to the IATF-EID guidelines, work in government offices may be at full operational capacity, or under such alternative work arrangements as agencies may deem appropriate in accordance with relevant rules of the Civil Service Commission.

SECTION VII. PUBLIC TRANSPORTATION.

Section VII.1 Only public utility jeepneys whose operators or drivers have been granted special permits by the LTFRB are allowed to operate subject to 50% of seating capacity of the jeepneys.

Section VII.2 Public Utility tricycles shall continue to implement one passenger per ride policy.

Section VII.3 All drivers of public utility vehicles are mandated to wear face masks and goggles or any eye safety equipment.

Section VII.4 All frequently touched surfaces of the vehicle shall be regularly disinfected. Section VII.5 All public transportation terminals are required to implement checking of temperatures prior to allowing the passengers to board the public utility vehicle.

Section VII.6 Public utility jeepneys shall implement an alternative way of receiving jeepney fare instead of passing change from one passenger to another.

SECTION VIII. CHECKPOINTS ON BORDERS. Checkpoints located at the borders of the City shall remain and shall be supervised by the Philippine National Police.

SECTION IX. LOCALIZED QUARANTINE. In the event of a sudden surge of covid-19 cases in a particular barangay or sitio, the city government may order the temporary closure of the said barangay or sitio upon prior approval of the Regional Inter-Agency Task Force.

SECTION X. MASS GATHERINGS. Pursuant to the IATF-EID Guidelines, mass gatherings are now allowed subject to 50% of the seating or venue capacity. Provided, if the mass gathering shall be held inside residences, strict social distancing shall be observed by the homeowner.

SECTION XI. CURFEW. The curfew hours for non-frontliners shall be from 8PM until 5AM.

SECTION XII. TRAVEL AUTHORITY. Pursuant to the Guidelines of the Philippine National Police and of the National Task Force Against COVID-19 Order No. 2020 – 02, travels outside the provinces both for locally stranded individuals and indispensable travels require travel authority from the Philippine National Police. A barangay certificate that the LSI or traveler has

no covid symptoms in the past 14 days, and a medical clearance certificate from the City Health Office are required prior to issuance of the travel authority.

SECTION XIII. Consumption of alcoholic drinks outside one's residence is prohibited.

SECTION XIV. RETURNING MALOLENYOS. All returning Malolenyos upon arrival to the City shall immediately report to their Baranggay Officials of the fact of their arrival to the City in order to enable the Barangay Health Emergency Response Team to monitor their health status.

SECTION XV. SEPARABILITY CLAUSE. Should any provision of this Executive Order or any part thereof be declared invalid, the other provisions, insofar as they are separable from those declared invalid, shall remain in full force and effect.

SECTION XVI. EFFECTIVITY. This Executive Order shall take effect immediately upon signing thereof.
