EXECUTIVE ORDER NO. 03

AN ORDER PROVIDING FOR THE CREATION OF THE CITY OF MALOLOS COMMITTEE ON ANTI-TRAFFICKING AND ANTI-VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (CCAT-VAWC)

WHEREAS, the State condemns discrimination against women in all forms and pursues by all appropriate means and without delay the policy of eliminating discrimination against women in keeping with the Convention on the Elimination of All Forms of Discrimination Against Women (DECAW) and other international instruments consistent with the Philippine law. The State shall accord women the rights, protection and opportunities available to every member of society;

WHEREAS, on May 26, 2003, the Congress of the Philippines enacted Republic Act No. 9208, otherwise known as the "Anti-Trafficking in Persons Act of 2003;"

WHEREAS, on March 08, 2004, the Congress of the Philippines enacted Republic Act No. 9262, otherwise known as the "Anti-Violence Against Women and their Children Act of 2003;"

WHEREAS, the Magna Carta of Women (RA 9710) enacted on August 14, 2009 is a comprehensive women's human rights law the seeks to eliminate discrimination against women by recognizing, protecting, fulfilling and promoting the rights of Filipino women, especially those in the marginalized sectors;

WHEREAS, on October 18, 2010, Joint Memorandum Circular No. 2010-1 of the Department of the Interior and Local Government, the Department of Social Welfare and Development, and the Department of Justice provided for the establishment of Local Committees on Anti-Trafficking and Violence Against Women and their Children (LCAT-VAWC);

NOW THEREFORE, I, ATTY. CHRISTIAN D. NATIVIDAD, City Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by existing and applicable law, do hereby create the City of Malolos Committee on Anti-Trafficking and Anti-Violence against Women and their Children:

SECTION II: FUNCTIONS. The following are the functions of the City of Malolos Committee on Anti-Trafficking and Anti-Violence against Women and their Children:

- a. Institute policies and program to protect women and children who are victims of trafficking;
- b. Create and establish system on surveillance, investigation, and rescue to ensure effective and efficient coordination;
- c. Undertake information, education, and advocacy campaign against trafficking in persons and VAWC;
- d. Monitor and oversee the strict implementation of RA 9208, RA 9262, and other related laws for the Protection of Women and Children, and for the Inter-Agency Committee on AT and VAWC of action;

SECTION IV. SECRETARIAT. The Secretariat support shall be lodged with the City Social Welfare and Development Office, who shall be responsible for the documentation of proceedings of meetings and preparation of reports and other necessary documentations as needed by the council/committee;

SECTION V. SEPARABILITY CLAUSE - In the event that any section or part of this Order is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force or effect.

SECTION VI. REPEALING CLAUSE - All orders, issuances, memoranda or any part thereof inconsistent with the provisions of this Order are hereby repealed, amended or modified accordingly.



SECTION VII. DISSEMINATION - A copy of this Executive Order shall be furnished to the Office of the Provincial Governor for its information and guidance pursuant to Sec. 455 (b)(1)(xii) of Chapter III Art. I of R.A. 7160 known as the "Local Government Code of 1991", and shall posted in the City Government of Malolos official website.

SECTION VIII. EFFECTIVITY - This Order shall take effect immediately upon signing.
