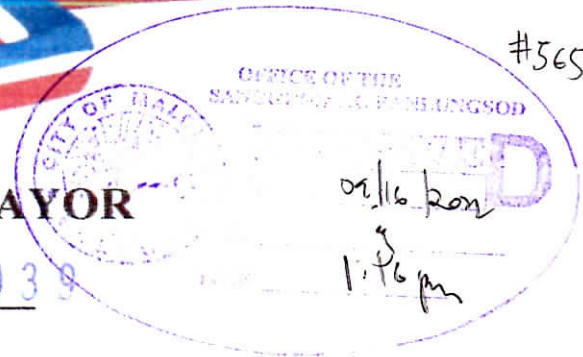

EXECUTIVE ORDER RECONSTITUTING THE CITY OF MALOLOS DEVELOPMENT COUNCIL, IDENTIFYING ITS MEMBERS, THEIR DUTIES AND FUNCTIONS AND OTHER PURPOSES

WHEREAS, Article 182 of the Implementing Rules and Regulations of the Local Government Code of 1991 (Republic Act No. 7160) mandates the creation of the Local Development Council (LDC);

WHEREAS, Section 106 of the same Code provides that each local government unit shall have a multi-sectoral development plan to be initiated by its LDC and approved by its Sanggunian;

WHEREAS, the LDC shall assist the Sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction;

WHEREAS, the recent local elections require reconstitution of the LDC due to the end of term of office of former LDC members;

WHEREAS, Section 112 of RA 7160, the LDC may form a sectoral or functional committees; and

WHEREAS, based on the above premises, the City Government would like to ensure the seamless transition to the new administration including the continuity of the functions and programs of the LDC;

NOW, THEREFORE, I, **ATTY. CHRISTIAN D. NATIVIDAD**, City Mayor of Malolos, by virtue of the powers vested in me by the law, do hereby order the reconstitution of the City of Malolos Development Council, with the following stipulations:

- a. Formulate long-term, medium-term, and annual socio-economic development plans and policies;
- b. Formulate the medium-term and annual public investment programs;

- c. Appraise and prioritize socio-economic development programs and projects;
- d. Formulate local investment incentives to promote the inflow and direction of private investment capital;
- e. Coordinate, monitor, and evaluate the implementation of development programs and projects; and
- f. Perform such other functions as may be provided by law or competent authority.

SECTION II. EXECUTIVE COMMITTEE (EXECOM) OF THE CMDC

The Executive Committee of the CMDC is hereby created to represent it and act in its behalf when it is not in session.

FUNCTIONS. The members of the sectoral or functional committees of the CMDC shall perform the following functions:

- a. Provide the CMDC with data and information essential to the formulation of plans, programs, and activities;
- b. Define sectoral or functional objectives, set targets, and identify programs, projects, and activities for the particular sector or function;
- c. Collate and analyze information and statistics and conduct related studies;
- d. Conduct public hearings on vital issues affecting the sector or function;
- e. Coordinate planning, programming, and implementation of programs, projects, and activities within each sector;
- f. Monitor and evaluate programs and projects; and
- g. Perform such other functions as may be assigned by the CMDC.

SECTION V. MEETINGS AND QUORUM

- a. The CMDC shall meet at least once every six (6) months or as often as may be necessary.
- b. The executive committee of the CMDC shall hold its meetings at least once every three months. Special meetings may be called by the chairperson or by a majority of its members.
- c. A majority of the members of the council shall constitute a quorum. The affirmative vote of a majority of the members shall be necessary to approve plans, policies, and program and project proposals.

SECTION VI. COMPENSATION AND REMUNERATION

The co-chairpersons and members of the CMDC shall perform their duties as such without compensation or remuneration. Members thereof who are not

government officials or employees shall be entitled to necessary traveling expenses and allowances chargeable against the funds of the CMDC, subject to existing accounting and auditing rules and regulations.

SECTION VII. TECHNICAL ASSISTANCE TO THE COUNCIL

All City Government Offices/Departments/Agencies are hereby enjoined to provide technical assistance, support and cooperation to the Council.

SECTION VIII. SEPARABILITY CLAUSE

If Any provision of this Executive Order is declared unconstitutional or invalid, such parts or portions not affected thereby shall remain in full force or effect.

SECTION IX. REPEALING CLAUSE

All orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION X. DISSEMINATION

A copy of this Executive Order shall be furnished to the Office of the Provincial Governor, for its information and guidance pursuant to Section 455 (1) (xii) of R.A. 7160, as amended, and shall be posted in the City Government of Malolos' official website.

SECTION XI. EFFECTIVITY

This Executive Order shall take effect immediately upon signing.
