

AN ORDER CREATING THE CITY OF MALOLOS MUSLIM CONSULTATIVE COUNCIL (CMMCC), DEFINING ITS DUTIES, FUNCTIONS AND FOR OTHER PURPOSES

WHEREAS, pursuant to Section 23 Article II of the 1987 Constitution provides that "the State shall encourage non-governmental, communitybased, or sectoral organizations that promote the welfare of the nation;

WHEREAS, in the formulation of plans, policies and programs, the State through its local government units shall recognize, respect and protect the rights of cultural communities to preserve and develop their cultures, traditions, institutions and well-being pursuant to Section 17 Article XIV of the 1987 Constitution;

WHEREAS, the City Government of Malolos recognizes the rights and well-being of Filipino Muslims in the City with due regard to their beliefs, customs, traditions and institutions, as well as to further ensure their contribution to the goals and aspirations of the City and also to make them participants in nation-building;

WHEREAS, preservation and development of the culture, traditions and institutions and well-being of Muslims in Malolos, in conformity with the national unity and development are found essential;

NOW THEREFORE, I, CHRISTIAN D. NATIVIDAD, Mayor of the City of Malolos, Province of Bulacan, by virtue of the power vested in me by law, do hereby order the creation of Muslim Consultative Council, their composition and function to wit:

Section I. COMPOSITION. The composition of the officers of the Muslim Consultative Council in the City of Malolos shall be determined by assembly through or election a general be attended by from duly recognized and members/representatives Sangguniang Panlungsod accredited Muslim organization in the City of Malolos;

Section III. FUNCTIONS. Muslim Consultative Council in the City of Malolos shall discharge and exercise the following functions, duties and responsibilities:

- a. Provide advice and assistance to the City Mayor in formulation, coordination, and implementation and monitoring of policies, plans, programs, projects and activities and other issues and concerns affecting Muslim communities in the City of Malolos;
- b. Coordinate with and seek assistance, support and cooperation from other government agencies and offices and other private parties/entities/ NGOs/CSOs in pursuit of the attainment of the policies set forth herein;

- c. Assist, render advice and/or recommend to the City Mayor proper measures, plans, programs, projects and activities for purposes of promoting peace and order, general welfare, political and socioeconomic rights and cultures of Muslims in the City of Malolos;
- d. Organize Muslims communities/organization/groups in the City of Malolos for purposes of representation and consultation, participation in capacity-building, setting of alternative dispute resolution/paralegal training, integration in the society, and partnership in the development of Muslim Communities and the City;
- e. Engage in the planning, implementation and enforcement, and review of policies, programs, projects and activities of the City of Malolos government relative to housing, socio-economic, peace and order, disaster risk reduction and management, education and social protection, gainful activities/business development and promotion of halal products, volunteerism and engagement in social development and governance among others;
- f. Educate Muslims constituents in the City of Malolos to register at the Commission on Election and exercise their right to vote pursuant to the constitution provision on suffrage;
- g. Render/submit periodic reports to the City Mayor on its accomplishments and social impacts, plans and recommendations on relevant issues and concerns affecting the lives and welfare of the Muslims inhabitants and its relations to the other stakeholders; and

h. Perform such other related functions, duties and responsibilities as may be assigned or delegated by the City Mayor or as may be required by law or ordinance.

SECTION IV. SEPARABILITY CLAUSE. In the event that any section or part of this Order is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force or effect.

SECTION V. REPEALING CLAUSE. All orders, issuances, memoranda or any part thereof inconsistent with the provisions of this Order are hereby repealed, amended or modified accordingly.

SECTION VI. DISSEMINATION. Let a copy of this Order be sent to the Office of the Provincial Governor pursuant to Sec. 455 (b)(1)(xii) of Chapter III Art. I of R.A. 7160 known as the "Local Government Code of 1991", the City Mayor shall furnish copies of executive orders issued by him, to the provincial governor within seventy-two (72) hours after their issuances.

SECTION VII. EFFECTIVITY. This Order shall take effect immediately upon signing.
