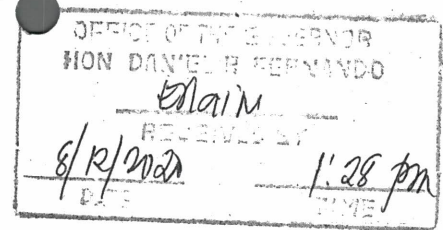

EXECUTIVE ORDER NO. 42 Series of 2020

AN ORDER PROVIDING FOR THE IMPLEMENTATION OF REGULAR DENGUE CLEAN-UP DRIVE IN THE CITY OF MALOLOS.

WHEREAS, it is the policy of the State to protect and promote the right to health and the right to a balanced and healthful ecology of the people;

WHEREAS, the number of suspect Dengue Cases in the Province of Bulacan has already reached 1,652 cases while 10 deaths has already been recorded in the Province for the first semester of 2020;

WHEREAS, every local government unit is mandated to promote the General Welfare of its people;

WHEREAS, pursuant to Section 455, (2) (iii) of the Local Government Code of 1991, the City Mayor as the Chief Executive of the city government has the power to issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

NOW THEREFORE, I, ENGR. GILBERT T. GATCHALIAN, City Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by law, do hereby order:

SECTION I. OBSERVANCE OF THE 4 O'CLOCK IN THE AFTERNOON DENGUE PREVENTION HABIT. All Punong Barangays are directed to encourage their respective constituents to clean their respective place of residence and to regularly check possible breeding places of dengue mosquitoes. For this purpose, Barangay Personnel shall remind the community about the 4 o'clock daily habit every Wednesday afternoon.

SECTION II. REGULAR CLEAN UP OF IRRIGATION SYSTEM. The City Waterways Irrigation Task Force shall regularly coordinate with the Barangay Officials in order to ensure that clean up of watery areas not limited to irrigation system shall be regularly conducted.

SECTION III. EFFECTIVITY. This Order shall take effect immediately upon signing.

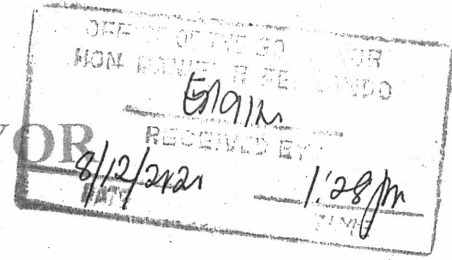
