EXECUTIVE ORDER NO. 43 Series of 2020

AN ORDER CREATING THE TECHNICAL WORKING GROUP FOR THE REHABILITATION OF THE SLAUGTERHOUSE OF THE CITY OF MALOLOS

WHEREAS, the Local Government Code of 1991 mandates every local government unit to exercise powers and discharge functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of basic services and facilities to its Constituents;

WHEREAS, a City Slaughterhouse is among the basic facilities that shall be provided by a City to its Constituents;

WHEREAS, pursuant to Section 455, (2) (iii) of the Local Government Code of 1991, the City Mayor as the Chief Executive of the city government has the power to issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

NOW THEREFORE, I, ENGR. GILBERT T. GATCHALIAN, City Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by law, do hereby order:

SECTION I: Creation of the Technical Working Group for the Rehabilitation of the Slaughterhouse of the City of Malolos. There shall be created a Technical Working Group for the Rehabilitation of the Slaughterhouse of the City of Malolos, the composition of which shall be as follows:

SECRETARIAT: The Malolos Public Market Division shall assist the Sanitation Division of the City Health Office in the performance of all secretariat functions in the Technical Working Group.

SECTION II: Duties and Functions of the Technical Working Group (TWG). The TWG shall conduct a study on the current status and operations of the slaughterhouse of the City, thereby creating a comprehensive Rehabilitation Plan of the same. The TWG shall endeavor to ensure that upon implementation of the Rehabilitation Plan, the City Government shall be able to comply with all pertinent standards of the National Meat Inspection Service in the construction, operation, and management of slaughterhouses.

SECTION III. Administration / Operation Costs. All costs that shall be incurred for the operations of the Technical Working Group shall be taken from the available funds of the City Government subject to applicable accounting and auditing rules and regulations.

SECTION IV. EFFECTIVITY. This Executive Order shall be effective immediately upon signing hereof.
