

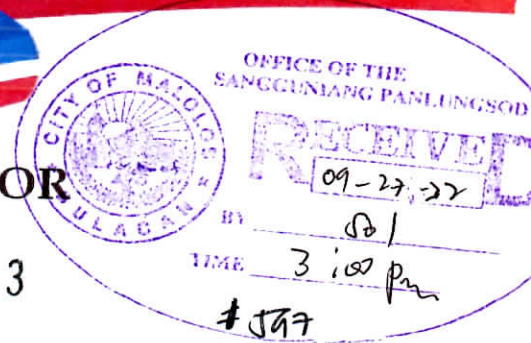

AN ORDER CREATING THE PEACE AND ORDER PLAN TECHNICAL WORKING GROUP (TWG) IN THE CITY OF MALOLOS

WHEREAS, Section 16 of RA 7160 mandates all local government units to ensure and maintain peace and order within their respective areas of jurisdiction;

WHEREAS, Section 5, Article II of the same affirms that the maintenance of peace and order, the protection of life, liberty, and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy;

WHEREAS, the threat, danger, and menace to peace and order posed by criminality, insurgency, and subversion places the LGU in an immeasurable risk and requires the collective and concerted efforts of all the government agencies concerned;

WHEREAS, Section 116 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in relation to Executive Order No. 309, series of 1987 of the Office of the President, as amended by Executive Order No. 773, series of 2009 mandates the creation and organization of the (Provincial/City/Municipal Peace and Order Council);

WHEREAS, the Department of the Interior and Local Government issued Memorandum Circular No. 2019-143, entitled Omnibus Guidelines for Peace and Order Council, the creation of Peace and Order Plan Technical Working Group;

WHEREAS, pursuant to Section 465 (2) (iii) of Republic Act No. 7160, the LCE shall issue Executive Orders for the faithful and appropriate enforcement and execution of laws and ordinances.

NOW THEREFORE, I, ATTY. CHRISTIAN D. NATIVIDAD, Mayor of the City of Malolos, Province of Bulacan, by virtue of the power vested in me by law, do hereby the creation of the City Peace and Order Council Technical Working Group (CPOC-TWG), to wit:

SECTION I. COMPOSITION. The component CPOC-TWG is hereby reorganized to be composed of the incumbent officers or officials of the following:

SECTION II. DUTIES AND FUNCTIONS OF THE CITY PEACE AND ORDER COUNCIL TECHNICAL WORKING GROUP. The City Peace and Order Council Technical Working Group shall perform and carry out the following roles and responsibilities:

1. Lead in the formulation of POPS Plan;
2. Prepare Documents that could serve as reference for the profiling of the strategic direction and peace and order and public safety issues in the locality;
3. Conduct data gathering and stakeholder consultations as needed and analyze data gathered;
4. Coordinate with communities or barangays for a head, data gathering and action planning for the implementation of POPS Plan;
5. Coordinate with Sub-Committee Heads relative to the recommended PPSAs for inclusion in the POPS Plan;
6. In coordination with the POC Chair and Secretariat Head, convene the POC and present the POPS Plan for discussion, approval and appropriate actions;
7. Present date to POC Chair for prioritization of issues and development strategies;
8. Draft and finalize the POPS Plan;
9. In coordination with the City Mayor, convene the POC and present the POC Plan for discussion, approval and appropriate action;
10. Take part in the submission and Sangguniang Panlungsod adoption of the POPS Plan;

11. Encode the POPS Plan in the POPS-PCMS;
12. Coordinate with internal and external stakeholders for effective communication and monitoring as laid out in the POPS Plan;
13. Ensure inclusion of key programs or strategies (DILG MC No. 2015-128 Annex 3) CSOP, and conflict sensitivity, if deemed appropriate, in the POPS Plan;
14. Submit the following reports:
 - a. Semestral accomplishment report not later than 15th day of August for the 1st Semester and 15th day of March for 2nd Semester;
 - b. Annual Report not later than 15th day of March
15. Perform such other tasks as maybe directed by the council.

SECTION III. MEETINGS. The CPOC-TWG shall meet every month, or as often as needed, to discuss relevant concerns on peace and order and public safety. After the quorum has been proven, the TWG Chairperson shall preside over the meeting or in case of the latter's absence, TWG Chairperson shall designate any member of the Council to preside at the meeting.

SECTION IV. SEPARABILITY CLAUSE. If any provision of this Act is declared unconstitutional or invalid, such parts or portions not affected thereby shall remain in full force and effect.

SECTION V. REPEALING CLAUSE. All orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION VI. DISSEMINATION. A copy of this Executive Order shall be furnished to the Office of the Provincial Governor, for its information

and guidance pursuant to Section 455 (1) (xii) or R.A. 7160, as amended, and shall be posted in the City Government of Malolos' official website.

SECTION VII. EFFECTIVITY. This Order shall take effect immediately.
