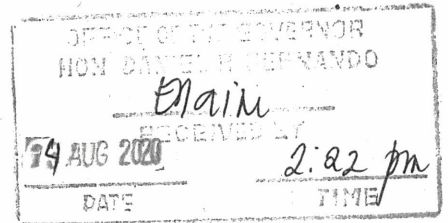

EXECUTIVE ORDER NO. 44 Series of 2020

AN ORDER CREATING THE SPECIAL APPRAISAL COMMITTEE DEDICATED TO THE LOCAL HOUSING PROJECT OF THE CITY OF MALOLOS.

WHEREAS, the Local Government Code of 1991 mandates every local government unit to exercise powers and discharge functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of basic services and facilities to its Constituents;

WHEREAS, Programs and Projects for low-cost housing and other mass dwellings are among the basic services and facilities that shall be provided by a City to its Constituents;

WHEREAS, pursuant to Section 455, (2) (iii) of the Local Government Code of 1991, the City Mayor as the Chief Executive of the city government has the power to issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

NOW THEREFORE, I, ENGR. GILBERT T. GATCHALIAN, City Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by law, do hereby order:

SECTION I: Creation of the Special Appraisal Committee dedicated to Local Housing Project of the City of Malolos. There shall be created a Special Appraisal Committee dedicated to the Local Housing Project of the City, the composition of which shall be as follows:


SECRETARIAT : The Office of the City Planning and Development Office shall act as the Secretariat to the Special Appraisal Committee.

SECTION II: Duties and Functions. The Special Appraisal Committee shall ensure proper appraisal and valuation of all prospective tracks of land fit for the implementation of the Local Housing Project of the City of Malolos.

SECTION III. Administration / Operation Costs. All costs that shall be incurred for the operations of the Special Appraisal Committee shall be taken from the available funds of the City Government subject to applicable accounting and auditing rules and regulations.

SECTION IV. EFFECTIVITY. This Executive Order shall be effective immediately upon signing hereof.
