

WHEREAS, Article 2 Section 13 of the 1987 Constitution states that, "the States recognizes the vital role of the youth in nation building and shall promote and protect their physical, moral, spiritual, intellectual and social well-being. It shall inculcate in the youth, patriotism and nationalism and encourage their involvement in public and civic affairs";

**WHEREAS**, Section 23 of Republic Act 10742 otherwise known as the Sangguniang Kabataan Reform Act provides that there shall be in every province, city and municipality a Local Youth Development Council (LYDC) mandated to assist the planning and execution of projects and programs of the Sangguniang Kabataan, and the Federations in all levels;

**WHEREAS**, the youth council shall serve as the main advocate for youth participation in nation-building and youth empowerment, monitoring and implementation of programs and projects under the Local Youth Development Plan;

**WHEREAS**, is a declared policy of the locality to promote and protect the physical, moral, spiritual, intellectual, cultural, and social well-being of the youth and to inculcate in them values of patriotism and nationalism and to encourage their involvement in public and civic affairs of the city;

**WHEREAS**, it is the duty of the city to reach out to the youth in the barangay and to encourage them to actively participate and be involved in its programs;

**WHEREAS**, the City Government of Malolos would like to ensure that the youth are given priority and that programs and polocies will be truly beneficial to them;

WHEREAS, Section 24(i) Rule III of the Rules and Regulations Implementing Republic Act 10742 states that the LYDC shall be composed at least (10) but not more than twenty one (21) members including the two (2) core members shall composed of the president and vice president of the concerned Federation and shall be supported by at least eight (8) but not more than nineteen (19) other representatives from registered youth organizations and youth-serving organizations;

**NOW THEREFORE, I, ATTY. CHRISTIAN D. NATIVIDAD,** City Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by existing and applicable law, do hereby order the following:

**SECTION I. NAME AND NATURE OF OFFICE.** The council shall be known as Local Youth Development Council of the City of Malolos. It shall be under the Office of the City Mayor and shall be headed by the City SK Federation President as the Presiding Officer.

SECTION II. CREATION AND COMPOSITION OF THE CITY OF MALOLOS LOCAL YOUTH DEVELOPMENT COUNCIL. The Local Youth Development Council hereby created and shall be composed of the following:

**SECTION III: DUTIES AND FUNCTIONS.** The LYDC shall discharge the following duties and functions:

- a. Serve as the core of the advocacy on youth participation in nation-building and youth empowerment;
- b. Finalize the three (3) year LYDP that is anchored in the PYDP and the development plans of Local Government Unit of City of Malolos, Bulacan;

The LYDP shall be initially drafted by the respective SK Federation and shall be finalized by the LYDC. This shall be submitted to the Local Chief Executive for inclusion in the Local Development Plan and subsequently endorsed to

the Sangguniang Panlungsod for approval. These plans shall give priority to programs, projects and activities that will promote and ensure the meaningful youth participation in nation-building, sustainable youth development and empowerment, equitable access to quality education, environmental protection, climate change adaption, disaster risk reduction and resiliency, youth employment and livelihood, health and anti-drug abuse, gender sensitivity, social protection, capability building and sports development;

- c. Monitor and evaluate the implementation of the Local Youth Development Plan; and
- d. Perform such other functions as may be prescribed by law or ordinance.

**SECTION IV. CONVENING OF THE LYDC.** The SK Federation President, or in his absence, the vice president shall convene the council and shall preside over all its meetings. The LYDC shall schedule a meeting every quarter, and as often as needed. However, if the president or the vice president fails to convene the LYDC as scheduled, at least one-third of its total membership may call for a meeting. In both instances, a written notice shall be sent, either through traditional or non-traditional means, to all members setting the date, time, place and agenda of the meeting which must be received at least two (2) days in advance. The presence of the majority of all members of the LYDC shall constitute a quorum.

**SECTION V. TERM OF LOCAL YOUTH DEVELOPMENT COUNCIL.** The members of the LYDC shall have a term of three (3) years unless sooner removed due to dissolution of the youth organization or youth serving organization or voluntarily vacates the position as member of the LYDO. A member who, during her/his term of office, shall have passed the age of thirty (30) years shall be allowed to serve the remaining portion of the term.

**SECTION VI. SECRETARIAT.** The Local Youth Development Officer (LYDO), **MR. BRYAN PAULO S. SANTIAGO**, shall provide secretariat services to the Local Youth Development Council. Accordingly, the LYDO shall assist in the conduct of meetings, take charge of communications and notices, prepare reports, and take custody of all records, data, information and documentations of the LYDC.

**SECTION VII. FUNDING.** The local government unit, through the Sangguniang Panlungsod, shall allocate support funds for the Local Youth Development Council subject to availability of funds and existing government accounting and auditing rules and regulations.

**SECTION VIII. SEPARABILITY CLAUSE -** In the event that any section or part of this Order is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force or effect.

**SECTION IX. REPEALING CLAUSE** - All orders, issuances, memoranda or any part thereof inconsistent with the provisions of this Order are hereby repealed, amended or modified accordingly.

**SECTION X. DISSEMINATION** - Let a copy of this Order be sent to the Office of the Provincial Governor pursuant to Sec. 455 (b)(1)(xii) of Chapter III Art. I of R.A. 7160 known as the "Local Government Code of 1991", the City Mayor shall furnish copies of executive orders issued by him, to the provincial governor within seventy-two (72) hours after their issuance.

**SECTION XI. EFFECTIVITY** - This Order shall take effect immediately upon signing.
