EXECUTIVE ORDER NO. 46 Series of 2020

AN ORDER RECONSTITUTING THE LOCAL HOUSING BOARD OF THE CITY OF MALOLOS.

WHEREAS, the Local Government Code of 1991 mandates every local government unit to exercise powers and discharge functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of basic services and facilities to its Constituents;

WHEREAS, Programs and Projects for low-cost housing and other mass dwellings are among the basic services and facilities that shall be provided by a City to its Constituents;

WHEREAS, pursuant to Section 455, (2) (iii) of the Local Government Code of 1991, the City Mayor as the Chief Executive of the city government has the power to issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

NOW THEREFORE, I, ENGR. GILBERT T. GATCHALIAN, City Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by law, do hereby order:

SECTION I: RECONSTITUTION OF THE LOCAL HOUSING BOARD OF THE CITY OF MALOLOS. There shall be created a Local Housing Board that shall ensure effective conceptualization and implementation of the Local Housing Project of the City.

SECTION III. EFFECTIVITY. This Executive Order shall be effective immediately upon signing hereof.
