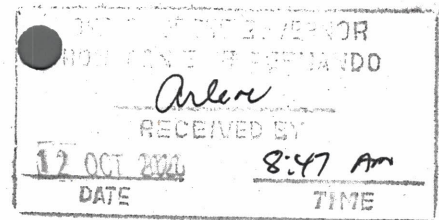

EXECUTIVE ORDER NO. 50, SERIES OF 2020

AN ORDER AMENDING SECTION 1 OF EXECUTIVE ORDER NO. 18 S. 2019 THE COMPOSITION OF THE CITY PEACE AND ORDER COUNCIL

WHEREAS, the Department of Interior and Local Government Memorandum Circular No. 2016-141 ordered the revitalization of the sub-national Peace and Order Councils;

WHEREAS, the Department of Interior and Local Government Memorandum Circular No. 2019-72 states the guidelines on the process for accreditation and selection of CSOs and their representatives to the local special bodies, and to strengthen their participation in local governance and development processes, reiterating and strengthening the provisions of RA 7160 and its Implementing Rules and Regulations;

WHEREAS, pursuant to the Section 455, (2) (iii) of the Local Government Code of 1991, the City Mayor as the Chief Executive of the city government has the power to issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

NOW, THEREFORE, I, ENGR. GILBERT T. GATCHALIAN, City Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by law, do hereby order the following:


