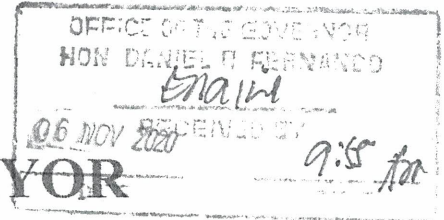

### EXECUTIVE ORDER NO. 60 Series of 2020

**AN ORDER ESTABLISHING FIRECRACKERS AND OTHER PYROTECHNIC DEVICES ZONE, DESIGNATED DISPLAY AREA AND GUIDELINES AND PROHIBITION FOR THE SALE, MANUFACTURE, DISTRIBUTION AND USE OF SUCH IN THE CITY OF MALOLOS.**

**WHEREAS**, Republic Act No. 7183 regulates and control the manufacture, sale, distribution and use of firecrackers and other pyrotechnic devices consistent with, and in furtherance of public safety, order and national security, as well as the enhancement of cultural traditions;

**WHEREAS**, Republic Act No. 7183 provide for the authority of the local government unit through the local chief executive to promulgate necessary rules and regulations on firecrackers and other pyrotechnic devices within their territorial jurisdiction in conformity with national standards, rules and regulations;

**WHEREAS**, Memorandum Order No. 28, s. 2017, by the President of the Philippines, provides for the regulation and control of the use of firecracker and other pyrotechnics devices;

**WHEREAS**, Memorandum Order No. 31, s. 2018, by the President of the Philippines, directs the Philippine National Police and other concerned agencies to strictly implement existing laws, rules and regulations on the sale, manufacture, distribution and use of firecrackers and pyrotechnic devices;

**WHEREAS**, pursuant to Section 455, (2) (iii) of the Local Government Code of 1991, the City Mayor as the Chief Executive of the city government has the power to issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

**NOW THEREFORE, I , ENGR. GILBERT T. GATCHALIAN**, City Mayor of Malolos, Bulacan, by virtue of the power vested in me, do hereby order the observance of the following guidelines as regards the selling, manufacturing, distribution and use of firecrackers and other pyrotechnic devices in the City of Malolos, Bulacan:

**SECTION I. QUALIFICATIONS OF MANUFACTURERS AND DEALERS.**

- a. Any person desiring to manufacture, sell or distribute fireworks and other pyrotechnic devices shall file his application for the issuance of license or business permit with the Chief of PNP, through the Provincial Director of the Province of Bulacan;
- b. Reasonable fees may be charged for the issuance of said licenses or permits to defray the cost of regulating the manufacture, sale and distribution of firecrackers and pyrotechnic devices;

**SECTION II. FIRECRACKERS AND OTHER PYROTECHNIC DEVICES ZONE.**

- a. The designated area/zone for selling of allowed firecrackers and other pyrotechnic devices shall be at Malolos Sports and Convention Center (MSCC), Barangay Bulihan, City of Malolos and such other places determined or permitted by the City Government of Malolos in coordination with the Philippine National Police.
- b. Any individual entity or corporation desiring to sell such items shall strictly comply with the provisions of RA 7183 and other related laws and issuances.
- c. The date of selling of allowed firecrackers and other pyrotechnic devices shall only be on December 16 to 31, 2020

**SECTION III. COMMUNITY FIREWORKS AND OTHER PYROTECHNIC DESIGNATED.** To minimize the risk of injuries and casualties, there shall be a designated fireworks other pyrotechnic display area for each barangay in the City of Malolos. (list attached)

**SECTION IV. PENALTY.** Any individual entity or corporation in violation of RA 7183, Executive Order No. 28, s. 2017, by the President of the Philippines and Memorandum Order No. 31, s. 2018, by the President of the Philippines and this Executive Order shall be punished in accordance with the provisions of the law.

**SECTION V. EFFECTIVITY.** This order shall take effect immediately upon signing hereof.
