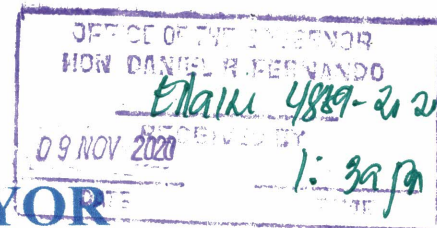

AN ORDER CREATING THE LISTAHANAN LOCAL VERIFICATION COMMITTEE OF THE CITY GOVERNMENT OF MALOLOS.

WHEREAS, the Department of Social Welfare and Development (DSWD) issued Department Order No. 1 Series of 2008, which provides for the Adoption of the Targeting System for Poverty Reduction as a Mechanism for identifying Potential Beneficiaries of the DSWD Social Protection Progress and Services;

WHEREAS, the National Statistical Coordination Board (NSCB) Resolution No. 18 series of 2009 recognized and enjoined Support to the Targeting System being implemented by the DSWD as a tool to identify the beneficiaries of Social Protection Programs;

WHEREAS, Executive Order No. 867 series of 2010 issued by then President Gloria Macapagal Arroyo provided for the adoption of the National Household Targeting System for Poverty Reduction (NHTS-PR) as the mechanism for Identifying individuals belonging to poor households who shall be the recipients of Social Protection Programs nationwide;

WHEREAS, Executive Order No. 867 series of 2020 mandates all National Government Agencies to use the Listahanan for their social protection programs and services;

WHEREAS, pursuant to Section 455, (2) (iii) of the Local Government Code of 1991, the City Mayor as the Chief Executive of the city government has the power to issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

NOW THEREFORE, I, ENGR. GILBERT T. GATCHALIAN, City Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by law, towards promotion of the General Welfare within the City, pursuant to the mandate by the Department of Social Welfare and Development, do hereby order:

SECTION I. CREATION OF THE LOCAL VERIFICATION COMMITTEE FOR NHTS-PR: A Local Verification Committee for the National Household Targeting System for Poverty Reduction (NHTS-PR) is hereby created. For brevity, said committee shall be called Listahanan Local Verification Committee, which shall be composed of the following:

SECTION II. FUNCTION: The Listahanan Local Verification Committee shall have the following functions:

1. Resolve all complaints and/or appeals brought about by individuals/groups;
2. Identify households, which status have not been amended based on appeal and complaints received;
3. Certify the completeness or incompleteness of the List of Households living below the poverty threshold along with recommended changes.

SECTION III . SEPARABILITY CLAUSE. If for any reason, any provision of this Order is declared unconstitutional or invalid, the remaining provisions not affected thereby shall continue to be in full legal force and effect.

SECTION IV. EFFECTIVITY. This Executive Order shall take immediately upon signing thereof.
