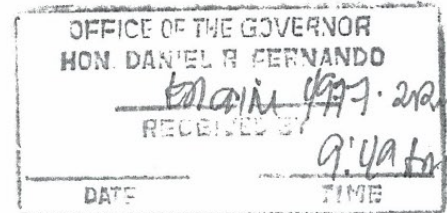

EXECUTIVE ORDER NO. **64**
Series of 2020

AN ORDER PROVIDING FOR THE GUIDELINES AND MEASURES THAT SHALL BE OBSERVED WITHIN THE CITY OF MALOLOS FROM 1 DECEMBER TO 31 DECEMBER IN CONNECTION WITH THE MODIFIED GENERAL COMMUNITY QUARANTINE.

WHEREAS, by order of the President of the Philippines, the Executive Secretary Atty. Salvador Medialdea, through a Memorandum dated 1 December 2020, informed the public of the approval of the community quarantine classification of Provinces, Highly Urbanized Cities and Independent Component Cities from 1 December to 31 December 2020;

WHEREAS, pursuant to the said Memorandum of the Executive Secretary, the community quarantine classification of the whole Province of Bulacan is Modified General Community Quarantine;

WHEREAS, the General Welfare Clause of the Local Government Code of 1991 provides, that within their respective territorial jurisdictions, local government units shall ensure the promotion of health and safety of their inhabitants;

WHEREAS, pursuant to Section 455, (2) (iii) of the Local Government Code of 1991, the City Mayor as the Chief Executive of the city government has the power to issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

NOW THEREFORE, I, ENGR. GILBERT T. GATCHALIAN, City Mayor of the City of Malolos, Bulacan, by virtue of the powers vested in me by law, towards promotion of the General Welfare within the City, do hereby order strict observance of the following policies and measures for the entire period of Modified General Community Quarantine in the City of Malolos:

SECTION I. ADOPTION OF THE OMNIBUS GUIDELINES ON THE IMPLEMENTATION OF COMMUNITY QUARANTINE IN THE PHILIPPINES FOR AREAS PLACED UNDER MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ) AND OTHER RELEVANT ISSUANCES:

1. Only Authorized Persons Outside of Residence (APOR) and persons between the ages of 15 and 65 years old who are neither pregnant nor having immunodeficiency, comorbidity, or other health risk, are allowed to go outside of residence;
2. The movement of all persons allowed to go outside of residence shall be limited to accessing essential goods and services, for work in the offices and industries allowed to operate during MGCQ and only for the activities allowed within areas under MGCQ;
3. Minimum public health standards shall be observed at all times, such as but not limited to mandatory wearing of face masks, frequent hand washing, strict observance of social distancing, wearing of face shields, and regular disinfection of public areas;
4. Indoor and outdoor non-contact sports and other forms of exercises are allowed. However, the no-spectator policy shall at all times be observed.
5. Mass gatherings shall be allowed provided that the number of participants shall be limited to 50% of the seating or venue capacity. The Malolenyos are strictly discouraged to hold any non-essential mass gathering. Only work conferences and religious services are the encouraged form of mass gathering;
6. For purposes of learning and education, the relevant guidelines of the Department of Education, the Commission on Higher Education, and the Technical Education and Skills Development Authority (TESDA) shall apply;
7. Work in all public and private offices may be at full operational capacity. Persons who are 60 years old and above, those with immunodeficiency, comorbidity, or other health risks, including pregnant women shall work under alternative work arrangements;
8. All public and private constructions are allowed subject to compliance with the Department of Public Work and Highways Department Order No. 39 Series of 2020 and Department Order No. 2020-005 of the Department of Human Settlements and Urban Development;
9. All establishments are enjoined to strictly observe the categorization and allowable operational capacity provided under the Department of Trade and Industry Memorandum Circular 20-52 signed 2 October 2020. A copy of the said Memorandum Circular is hereto attached as ANNEX A. However, for the following establishments, the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines with Amendments as of 19 November 2020 shall govern:
 - a. Barbershops, salons, and other personal care service establishments, at a maximum of 50% of venue capacity;
 - b. Dine-in restaurants, fast food and food retail establishments, including supermarkets, grocery stores, and food preparation establishments at a maximum of 50% seating capacity;
10. The following are business activities not allowed to operate under MGCQ:
 1. Beerhouses and similar establishments whose primary business is serving alcoholic drinks;
 2. Kid amusement industries.

10.1. Pursuant to the IATF Resolution No. 79, the operations of licensed cockpits on a 20% operational capacity and the resumption of cockfighting activities is hereby allowed to proceed within the City of Malolos. However, owners and operators of licensed cockpits within the City shall strictly comply with the DILG Memorandum Circular No. 2020-140, which provides for the Guidelines on the Resumption of Cockpit Operations or Cockfighting in Areas under Modified General Community Quarantine.

11. Accredited Diplomatic missions and international organizations may resume in full operations.
12. Public Transportation operators shall comply with the relevant guidelines of the Land Transportation Franchising and Regulatory Board (LTFRB). All public transportation terminals shall strictly practice health and physical distancing protocols and shall implement no face shield and face mask, no ride policy. The one-meter distance between passengers shall at all times be observed.

SECTION II. LOCALIZED QUARANTINE, CONTACT TRACING AND SWABBING.

The City through the City Disaster Risk Reduction and Management Office, the City Health Office, the City Police Force, and the Liga ng mga Barangay shall work in full coordination and cooperation in order to ensure timely implementation of localized containment as may be deemed necessary.

The City Health Office Contact Tracing Team and Swabbing Team are hereby mandated to maximize all available resources towards ensuring 100% contact tracing and timely swabbing.

SECTION III. CURFEW. Except for APORS, curfew within the City of Malolos shall be from 11PM until 4AM.

SECTION IV. MANDATORY DIGITAL CONTACT TRACING. Pursuant to the Resolution No. 85 of the IATF dated November 26, 2020, all public and private offices, establishments, and facilities, are required to use the StaySafe.ph contact tracing application.

SECTION V. FULL COMPLIANCE. The Chief of Police shall work with the Liga ng mga Barangay, the Traffic Management Group, and the Business Permit and Licensing Division under the City Administrator's Office to ensure full compliance with this Executive Order and with the existing Ordinances and relevant law, rules and regulations. Among others, only persons allowed to go outside of residence shall be seen roaming around the City; curfew and strict physical distancing under all circumstances shall be implemented.

SECTION VI. MONITORING OF COMPLIANCE. The Police Force of the City shall submit to the Office of the City Mayor a report every two weeks (bi-monthly) on the status of compliance of the Malolenyos with the policies and protocols enumerated herein and other relevant law, rules and regulations issued by the National Agencies. In the same vein, The Business Permit and Licensing Office shall submit to the Office of the City Administrator a bi-monthly report on the status of compliance of the establishments located within the City.

SECTION VII. INTERZONAL AND INTRAZONAL MOVEMENT. Unless otherwise directed by the Department of the Interior and Local Government, the One Stop Shop for the

granting of travel authorities required for interzonal and intrazonal movement shall continue to operate. Only travels allowed under the IATF-EID Guidelines shall be permitted.

SECTION VIII. BALIKBAYANS, RETURNING MALOLENYOS OFWs. Returning residents shall comply with the relevant guidelines of the Overseas Workers Welfare Administration, the Department of the Interior and Local Government and the Department of Health. All returning residents are hereby required to report immediately to the Barangay Hall upon arrival to the City.

SECTION IX. CONSUMPTION OF ALCOHOLIC BEVERAGE OUTSIDE RESIDENCE. Consumption of alcoholic beverages outside one's own residence shall be strictly limited to 2 bottles per person at any given time. Establishments offering alcoholic beverages shall prepare a log sheet of the account of alcoholic beverages served per customer that shall be presented during random inspection that may be conducted by the Business Permit and Licensing Office and/or the Members of the Malolos City Police.

SECTION X. HOLDING OF WAKE AND FUNERAL. It is hereby declared that the holding of wakes within the City of Malolos shall not exceed three (3) days for non-covid related deaths. Said period shall be extendible up to five (5) days upon the discretion of the City Health Officer.

SECTION XI. INCORPORATION CLAUSE. All laws, rules and regulations and issuances issued under the authority of the National Government and of the Provincial Government are hereby incorporated and shall form integral parts of this Order.

SECTION XII. EFFECTIVITY. This Order shall take effect immediately upon signing hereof.
