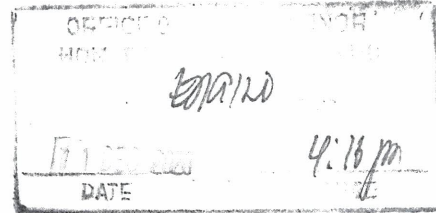

EXECUTIVE ORDER NO. 65 SERIES OF 2020

### AN ORDER REORGANIZING THE LOCAL ZONING REVIEW COMMITTEE (LZRC) AND DEFINING ITS FUNCTIONS

**WHEREAS**, Municipal Ordinance No. 6-97 or known as Comprehensive Zoning Code for the Municipality of Malolos is an important tool and regulatory measure for the implementation of Comprehensive Land Use Plan (CLUP);

**WHEREAS**, Section 10, Article X of the said ordinance mandated the creation of a Local Zoning Review Committee;

**NOW, THEREFORE, I, ENGR. GILBERT T. GATCHALIAN**, City Mayor of Malolos, by virtue of powers vested in me by law, do hereby create the Local Zoning Review Committee (LZRC) with the following provisions:

## SECTION II. POWERS AND FUNCTIONS

1. Review the zoning ordinance for the following purposes:
  - a. Determine the amendments or revision necessary in the zoning ordinance brought about by changes that might have been introduced in the Local Development Plan.
  - b. Identify the provisions of the code found difficult to enforce.
2. Recommend to the Sangguniang Panlungsod necessary legislative amendments and to the City Planning and Development Office the needed changes in the plan as a result of the review conducted by it.
3. Provide information to the Department of Human Settlement and Urban Development that would be useful in the exercise of its functions.

## SECTION III. SECRETARIAT

The City Planning and Development Office shall serve as the secretariat to the Local Zoning Review Committee (LZRC).

## SECTION IV. EFFECTIVITY

The Executive Order shall take effect immediately upon signing.
